This enables us to enhance your browsing experience, improve the Website, and deliver content and services that are more relevant to you. ## 01. WHAT ARE COOKIES?

- (a) Cookies are small text files containing information that are stored on your device (computer, smartphone, tablet, etc.) when you visit a website. Cookies allow the website to recognize your device, remember your preferences, and help enhance your overall experience.
- (b) Cookies do not typically contain personally identifiable information. However, information stored in cookies may be linked to personal data collected from you elsewhere, depending on how you use our services.

## 02. TYPES OF COOKIES WE USE

We use the following types of cookies on our website:

### (a) Strictly Necessary Cookies

These cookies are essential to enable you to navigate the Website and use its features. Without these cookies, certain services cannot be provided.

Examples include:

- Remembering your login status during your session.
- Enabling secure payment and transaction functionality.
- Authenticating your access to secure parts of the Website.

### (b) Performance and Analytics Cookies

These cookies collect information about how visitors use our Website. They help us understand which pages are most frequently visited and if users encounter errors. All data collected is aggregated and anonymous.

Examples include:

- Google Analytics cookies tracking user interaction.
- Error tracking cookies to detect and log website glitches.

### (c) Functionality Cookies

These cookies allow the Website to remember choices you make and provide more personalized features.

Examples include:

- Storing your language preferences.
- Remembering your region or account-specific settings.

(d) Advertising and Targeting Cookies

These cookies are used to deliver advertisements more relevant to you and your interests. They may also be used to measure the effectiveness of an advertising campaign.

Examples include:

- Tracking whether advertisements are clicked.
- Preventing repeated display of the same advertisement.
- Displaying content tailored to your browsing behavior.

(e) Third-Party Cookies

Some cookies on our Website may be set by third parties that we work with, such as advertising networks or analytics service providers. These third parties may use cookies to collect information about your browsing activity across different websites.

We do not control the use of these cookies, and you should check the third-party provider's website for more information.
