### **Privacy statement**

This privacy information applies to personal information collected through this website.

## **Purpose**

### Scope

### Collection, storage and use

### Call recording and email retention

# Voluntary disclosure of personal information

## Electronic mailing list

# Holding of information

# Use of personal information

We will generally only use personal information provided to us through this website for the purpose you provided it (i.e. for marketing, sales, and communication).

#### Disclosure of information

We will generally not share personal information that is provided or collected through this website, unless it is necessary to do so for the purpose for which you gave us the information or where you consent. We will not otherwise disclose personal information provided or collected through this website unless required or otherwise permitted by law.

# Records and retention of personal information

We will only retain personal information as long as it is required for the purposes for which the information may lawfully be used.

When your Personal Information is no longer needed for the purpose for which it was obtained, we will take reasonable steps to destroy or permanently de-identify your Personal Information. However, most of the Personal Information is or will be stored in customer files which will be kept by us for a minimum of seven years.

# Security

Our website has security measures in place to prevent the loss, misuse and alteration of information under our control. To maintain the security of our systems and information, our systems are subject to ongoing monitoring (including activity logging), analysis and auditing.

We may use information about your use of our websites and other IT systems to prevent unauthorized access or attacks on these systems or to resolve such events. We may use this information even if you are not involved in such activity.

We may use services from one or more third party suppliers to monitor or maintain the cyber security of our systems and information. These third-party suppliers will have access to monitoring and logging information as well as information processed on our websites and other IT systems.

## Rights of access and correction

You have the right to:

- request corrections of that information

If we have a good reason for refusing a request for correction, you are entitled to request that a statement be attached to the information of the correction that was sought but not made.
