I am aware that the law allows such information to be released to: 1) an official or employee of the state, a political subdivision of the state, or the United States acting in an official capacity; 2) an employee of a utility acting in connection with the employee's duties, 3) a consumer reporting agency; 4) a contractor or subcontractor approved by and providing services to the utility, the state, a political subdivision of the state, or the United States; 5) a person to whom I have contractually waived the confidentiality of my personal information; or 6) another entity that provides water/wastewater, sewer, gas, garbage, electricity, or drainage service for compensation. I am also aware that I may rescind this request for confidentiality by providing the City of San Juan written permission to disclose personal information. By checking the box below, I direct the City of San Juan not to release: 1) my personal information; 2) my utility usage; and 3) amounts billed or collected from my account as it relates to utility usage.
