# Introduction

Most websites you visit will use cookies in order to improve your user experience by enabling that website to 'remember' you.

If a website does not use cookies, it will think you are a new visitor every time you move to a new page on the site.

### 1. What is a cookie?

A cookie is a small, often encrypted text file that is stored on your computer or mobile device by a website's server and only that server will be able to retrieve or read the contents of that cookie. Each cookie is unique to your web browser. It will contain some anonymous information such as a unique identifier and the site name and some digits and numbers. It is used to help users navigate websites efficiently and perform certain functions. In this Cookie Policy where we refer to "session cookies" this refers to cookies which are stored temporarily and automatically deleted when you closer your browser, and where we refer to "permanent cookies" this means cookies which are saved within your browser until they expire, or when you clear your browsing data.

# 2. What types of cookies are used on our Sites?

# Compliance cookies

This cookie allows us to know whether or not you have given consent to the use of cookies and therefore do not need to be presented with this consent request message again

### Analytics and performance cookies

These cookies allow us to count page visits and traffic sources so we can measure and improve the performance of our site, using a service provided by Google Analytics.

### Functional and required cookies

These are cookies used for core site functionality.

#### Advertisement cookies

These cookies collect information about your browsing habits to show you advertisements relevant to your interests, including remarketing on other websites, based on the products and services you've viewed.

# • What happens if I refuse, block or delete cookies?
