On the Record; 1/28/2023

We are continuing to have discord in the maintenance department. The executive committee has been tasked with coming up with a plan to retain a maintenance crew. In doing so we, as well as several other board members and association members have spent an enormous amount of time to structure us in a fashion to obtain such. We continue to get feedback of Tony Hochstetler doing the exact opposite to undermine the work and progress we have made. His continual questioning, checking on, and discussing publicly is directly affecting the results of all the hard work for the fair. Tony was removed from the building and grounds committee to try to rectify this situation and that has not worked. This isn't the first, second, or even tenth time, it is constant. It is him constantly negatively questioning every choice made by board members or employees bringing down the moral of the fair. Yet when, himself, being questioned on what he is doing, he is highly offended. He continues to be insubordinate, stepping out of his lane based on nothing more than what he sees and his opinions. He does not communicate, ask the questions he has and help to rectify things for the fair or be an asset for a solution. He continues to be destructive in his actions instead of helpful. The continued negative attitude and actions will continue to be a problem for the fairgrounds until it stops 100%. Effective immediately, Tony Hochstetler is not to do anything on the grounds unless asked on a case-by-case basis. Anything more than this will not be in the best interest of the fair. The source of my information is Tony Hochstetler himself. Tony doesn't have discretion in his conversations and makes it common knowledge in his travels. We find his actions to be a great determinant to the fair's success. It is very unfortunate that after server discussions about communication and being helpful with a solution that this continues to transpire.

None of us wanted it to come to this but as leaders, it's not about what we want, it's about doing what is right for the fair. I challenge you all to have the courage to continue to lead and recognize the difference between duty and self.
