Hold Harmless/Indemnification: Vendor shall be solely responsible for any and all injuries to persons or damages of property or any other injury, claim, damage or loss of whatever nature, arising directly or indirectly from items sold or area rented at the Centreville Garage sale/Vintage Market. Vendor shall INDEMNIFY, SAVE AND HOLD HARMLESS St Joseph County Grange Fair and its employees, agents and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from the Centreville Garage Sale/Vintage Market.
