**Insurance and Hold Harmless/Indemnification Information:**

Each Vendor shall obtain and keep in force until completion of the Centreville Garage Sale and Vintage Market for date on form, including set up and tear down a general liability insurance contract with liability limits equal to or greater than \$1,000,000 each occurrence.

**IF SELLING FOOD OR EDIBLES OF ANY KIND:** The Vendor shall provide a certificate of insurance to St Joseph Co Grange Fair evidencing such coverage within 10 days of signed contract, valid for date of event. Such Vendor shall name St Joseph Co Grange Fair as Additional Insured.

**Hold Harmless/Indemnification:** Vendor shall be solely responsible for any and all injuries to persons or damages of property or any other injury, claim, damage or loss of whatever nature, arising directly or indirectly from items sold or area rented at the Centreville Garage sale/Vintage Market. Vendor shall **INDEMNIFY, SAVE AND HOLD HARMLESS** St Joseph County Grange Fair and its employees, agents and volunteers from and against all liability, loss, damages, claims, costs and expenses (including attorney fees) arising out of injury to person or damages to property or any other injury, claim, damage, loss, cost or expense arising from the Centreville Garage Sale/Vintage Market.
