





Carbon Offsets Explained

Carbon offsets are used by a company or organisation to compensate for what they are emitting and thereby decrease their net emissions. Offsetting involves purchasing carbon credits. Typically, one credit permits the emission of one tonne of carbon dioxide equivalent (CO2-e).1

We work closely with our clients and market leading climate experts through the four steps to become a Carbon Neutral business:









As one of the first carbon offset providers in Australia, Ozwide Energy and Carbon provides offset options, and then purchases offsets on your company's behalf to bridge the emissions gap to make your business carbon neutral.
