ADDENDUM TO WINTER STORAGE CONTRACT

Please initial that you have read and understand the following and return with contract:

Minmar winter storage is just that, storage facility only.
Minmar is NOT responsible for lost cushions, covers, missing tops or items from your boat such as rafts, jackets etc. Please be sure to remove these items before you bring your waverunner.
Minmar is NOT responsible for damage caused to waverunners by wild animals.
Winter storage is from November 1 st thru April 30 th . Any waverunner that does not have a contract for service or storage after that period will be charged a fee of \$2.50 per ft./per day. Please be on the look out for your Spring contracts so you may choose your make ready dates to avoid additional charges.
Minmar requires all customers to provide valid insurance certificate. Minmar Marine MUST be listed as an additional insured. Please send this in with the contract, we cannot store waverunners without it.
If you are planning on selling your waverunner in the spring, you must notify us before we put waverunner away and you must store OUTSIDE. If you store inside, we cannot guarantee access to your waverunner before mid-April. There are NO EXCEPTIONS to this as we do not have the ability to jockey waverunner's around.
If you are scheduling an outside vendor for winter work (which there is a charge for) you must notify us when you bring your waverunner in for the winter so we can do our best to accommodate.
All waverunners will be inspected upon arrival at Minmar and customers will be notified if anything is amiss.
