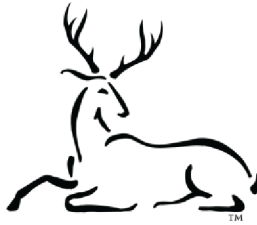
### CLUB MEMBERSHIP POLICY: DOMESTIC PARTNER ELEGIBILITY

The Snowmass Club (“the Club”) recognizes that individuals in long-term, committed relationships, regardless of marital status, may wish to share in the benefits and privileges associated with membership. Therefore, the Membership Plan governing the Snowmass Club states that membership in the Club entitles the Member's spouse (or any person deemed a spousal equivalent) Club use privileges. The following policy outlines the guidelines under which a Domestic Partner, who is not legally married to the Club Member, may be included in Snowmass Club membership privileges as a spousal equivalent.

#### Eligibility Criteria for Domestic Partner Designation:

1. **Relationship Definition:** A "Domestic Partner" is defined as a person with whom the Club Member has a committed, long-term relationship, resembling a family unit, but who is not legally married to the Club Member.
2. **Cohabitation Requirement:** The Domestic Partner must reside with the Club Member full-time at the same address. Proof of cohabitation is required for consideration.
3. **Documentation:** To apply for Domestic Partner designation, the Club Member must provide evidence that they and their Domestic Partner share a life and household. Acceptable documentation may include:
  - A joint lease or mortgage agreement in both names.
  - Recent utility bills, bank statements, driver's licenses or other official documents showing both individuals living at the same address.
4. **Discretionary Approval:** The Club reserves the right to approve or deny the inclusion of a Domestic Partner on a case-by-case basis. Approval is at the sole discretion of the Club management and may consider factors such as the nature of the relationship, the duration of cohabitation, and the overall fit with the Club's membership standards.
5. **Application Process:**
  - The Club Member must complete and submit the “Member Affidavit Requesting Domestic Partner Designation” and include documentation as proof of co-habitation and a shared life.
  - The significant other requesting Club usage as the Domestic Partner must complete and submit the “Domestic Partner Application.”
  - The Club will review the application and notify the Member of the decision.
  - If the request is approved, the Domestic Partner will be granted the same membership privileges as a spouse of a Member.
6. **Ongoing Verification:** The Club may periodically request updated documentation to verify that the Domestic Partner continues to meet the eligibility criteria, including cohabitation. Failure to provide requested documentation may result in the revocation of Domestic Partner designation.

**Note:** This policy is intended to ensure that the Club's membership remains inclusive while also maintaining its standards and integrity. The Club will treat all requests with sensitivity and respect for privacy.

### MEMBER AFFIDAVIT REQUESTING "DOMESTIC PARTNER" DESIGNATION

I understand that I have the right to request the termination of my Domestic Partner's privileges at any time, but only one request for Domestic Partner designation may be made in a membership year (June 1 – May 31).

I, the undersigned, acknowledge that in order to acquire and maintain Club membership use privileges for my Domestic Partner, I may be required to provide information requested by the Club from time to time, evidencing the existence of a significant relationship between myself and my Domestic Partner and our continued residency together.

I, the undersigned, hereby authorize the disclosure and release of any further information to the Club for the investigation of the qualifications of my significant other for Domestic Partner designation on my membership as the Club deems appropriate in order to confirm the existence and continued relationship between myself and my Domestic Partner. I, the undersigned, further authorize any person or entity to disclose to the Club any information requested by the Club.

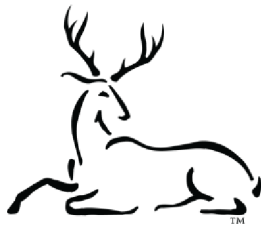

- ii. resignation or termination of Member's membership;
- iii. failure of myself, the Domestic Partner, to continue residence with the Member; or
- iv. upon discipline of myself, the Domestic Partner, by the Club as set forth in the Club's Rules and Regulations.

I, the undersigned Domestic Partner, further acknowledge and understand that if my membership privileges are terminated for any reason, I may be reinstated after 12 months at the sole discretion of the Club. The Club may, during this 12-month period and at its sole discretion, allow myself, the undersigned significant other, to access the Club as a guest.

I, the undersigned, further acknowledge that in order to acquire and maintain membership use privileges in the Club as a Domestic Partner under the Member's membership, I may be required to provide information requested by the Club from time to time evidencing the existence of the significant relationship between myself and the Member and continued residency together in order to protect the integrity of the Club.
