ORDINANCE 00-4

SUBJECT: ANNEXATION OF PROPERTY TO TOWN OF EVA

WHEREAS, on the 8 Day of August, 2000, the following Larry J. Smith and Janice H. Smith, being the owners of all the real property hereinafter described, did file with the Eva Town Clerk a petition asking that the said tract or parcel of land be annexed to and become a part of the town of Eva, Alabama; and

WHEREAS, said petition did contain the signatures of all the owners of the described territory and a map of said property showing its relationship to the corporate limits of the town of Eva; and

WHEREAS, the governing body did determine that it is in the best interest that said property be annexed to the Town of Eva and it did further determine that all legal requirements for annexing said property have been met pursuant to 11-42-20 through 11-42-24, Code of Alabama 1975:

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF EVA, ALABAMA, AS FOLLOWS:

Section 1 The Council of the Town of Eva, Alabama, finds and declares as the legislative body of the Town that it is in the best interest of the citizens of the Town and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the Town of Eva, Alabama.

Section 2 The boundary lines of the Town of Eva, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the Town of Eva, Alabama, and in addition thereto to the following described territory, to-wit:

Commence at the Southeast corner of the Northeast Quarter of the South West Quarter, Section 27, Township 8 South, Range 2 West; Thence North along the East line of said forty 125 feet more or less, to the South right-of-way of the Fairview-Eva Road (County Road 55), Thence N-49°30' W along said right-of-way 545 feet to a point, Thence S-63°19' W 260 feet to a point, thence S-12°41' E 341 feet, Thence S-87°00' E 568.4 feet to the point of beginning. Laying an being in the Northeast Quarter of the Southwest Quarter, Section 27, Township 8 South, Range 2 West and containing 5.0 acres, more or less.

Section 3 This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge or Morgan County, Alabama.

Section 4 The territory described in this ordinance shall become a part of the corporate limits of Eva, Alabama, upon publication of this ordinance as set forth in Section 3, above.
