

**ORDINANCE NUMBER 03-01**

**AN ORDINANCE REQUIRING A PERMIT FOR PARADES, PROCESSIONS, ASSEMBLIES, EVENTS AND DEMONSTRATIONS IN OR UPON THE PUBLIC STREETS AND WAYS IN THE TOWN OF EVA, ALABAMA; DECLARING IT A MISDEMEANOR TO VIOLATE THE PROVISIONS HEREOF; AND PROVIDING PUNISHMENT FOR VIOLATION**

**WHEREAS**, the Town of Eva, Alabama is growing and experiencing the various issues which come with growth; and

**WHEREAS**, the Town Council of the Town of Eva, Alabama ("Council") desires to be prepared to meet such issues as they arise; and

**WHEREAS**, it has come to the Council's attention that there is need for some provision for order in public parades, processions, assemblies, events and demonstrations.

**NOW, THEREFORE, be it ORDAINED** by the Town Council of the Town of Eva, Alabama, as follows, to-wit:

**Section 1.      Permit Required**

It shall be unlawful to promote, organize, hold or to assist in promoting, organizing or holding, or to take part or participate in any parade, procession, assembly, event or demonstration in the streets, highways or public ways and places of the town of Eva, Alabama, ("Town") unless a permit for such purposes has been first secured from the Town Council of the Town of Eva, Alabama ("Council").

**Section 2.      Application for Permit**

Before a permit for the purposes specified in Section 1 hereof can be secured, a written application for the permit shall be submitted to the Council, setting forth the following:

- (a)      the date(s), time(s); and
- (b)      the probable number of persons, vehicles and animal which may be involved; and
- (c)      the purpose for which the parade, procession, assembly, event or demonstration is to be held; and
- (d)      the street(s), highway(s), public way(s) or public place(s) where the parade, procession, assembly, event or demonstration is proposed to be held or over which passage is desired.

**Section 3.      Issuance of Permit, Terms and Conditions**

The Council shall issue a written permit for such parade, procession, assembly, event or demonstration prescribing the street(s), highway(s) or public way(s) or place(s) which may be used by the applicant, together with the date(s) and time(s) of such use and any other conditions deemed appropriate by the Council, unless in its judgment the public, welfare, safety, peace, health, good order or convenience require that the permit be

dollars (\$500.00) or by a jail sentence not to exceed six (6) months, or by both such fine and jail sentence, for any person, firm, corporation or other entity to violate any provision of this Ordinance or to exceed or violate the scope, terms or conditions of any permit issued pursuant to this Ordinance.

**Section 5.      Exemption**

There shall be no such permit required for a bona fide funeral procession.

**Section 6.      Effective Date**

This Ordinance shall be effective immediately upon its adoption and publication according to law.




