1. That Charles W. Nichols received a majority of the votes cast for the office of Councilmember, Place No. 1 and is hereby declared duly elected to that office for the term beginning on the first Monday in October, 1992.

2. That Clarence C. Alexander received a majority of the votes cast for the office of Councilmember, Place No. 2 and is hereby declared duly elected to that office for the term beginning on the first Monday in October, 1992.

3. That no candidate received a majority of the votes cast for the office of Councilmember, Place No. 3, and that James Afton Fowler and Mike Hopper received the most and second most votes cast for that office, therefore, a runoff election between said candidates is hereby ordered to be held on Tuesday, September 15, 1992, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.

4. That Gary Lewis Livingston received a majority of the votes cast for the office of Councilmember, Place No. 4 and is hereby declared duly elected to that office for the term beginning on the first Monday in October, 1992.

5. That Bert L. Collins received a majority of the votes cast for the office of Councilmember, Place No. 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in October, 1992.
