THE REGULAR MEETING OF THE MAYOR AND COUNCIL OF THE TOWN OF EVA, ALABAMA WAS HELD IN THE TOWN HALL ON AUGUST 8, 1974 AT 8:00 PM

THE MEETING WAS CALLED TO ORDER AND THE ROLL CALLED, ALL MEMBERS WERE PRESENT EXCEPT MR. L.G. MCDONALD. THE MINUTES OF THE LAST MEETING WAS READ AND ACCEPTED. DISCUSSION WAS HAD ABOUT THE ONE ROAD THAT IS NOT PAVED. THE ROAD IS ON THE WEST CITY LIMITS. THE ROAD IS TO BE PAVED AND NAMED. RIGHTS OF WAY HAVE BEEN OBTAINED. A MOTION WAS MADE BY CLAUD PATTON, TO LET THE PEOPLE WHO LIVE ON THE ROAD TO NAME IT. MOTION WAS SECOND BY JOHN SMITH ~~AND~~ AND PASSED BY COUNCIL.
