

MINUTES OF THE REGULAR MEETING OF THE MAYOR AND COUNCIL OF THE TOWN OF
EVA, ALABAMA, HELD ON DECEMBER 12, 1963.

The Mayor and Council of the Town of Eva, Alabama, held their regular meeting on December 12, 1963, at the school in the Town of Eva, Alabama, at 7:00 P.M.

The Mayor called the meeting to order and ask the Town Clerk to call the roll. All members of the governing body which consist of the Mayor and five Councilmen were present for this meeting. The Mayor then ask for the reading of the minutes of the previous meeting by the Clerk.
