NOTES TO AGENDA ITEM 4)B UTILITIES

Butch Tumlin, Compliance Officer with State of Alabama, Plumbers and Gas Fitters Examining Board, made visit to Town Hall on Tuesday, Noon, with Codes and Regulations concerning the same. Emphasied that State Code rules that connection from the meter to a structure for natural gas, water or sewer must be made by a certified plumber for installation, repair or replacement of pipes, fixtures or other apparatus necessary for supplying or removing. The term is used also to denotes installed fixtures, drainage, vents and water distribution systems.

He stated that permits should be used and should seek advise from Hartselle or Decatur inspectors. Also, indicated that if trouble should arrise in areas mentioned, legal suits can be prevented. (This is in reference to illegal plumbers performing work.)
