

Minutes of the regular meeting of the Eva Town Council held on April 14, 2015, 6:30 p.m. at the Eva Town Hall. Present: Mayor Gary Livingston, Council members Jim Henderson, Johnny Persall, Martin Nelson, Brandlee Shadden and Clerk Judy Fortenberry, Kent Chambers absence due to work.

Mayor Livingston called the meeting to order; all council members present except Kent Chambers. After roll call, informed all present that we open our meetings with prayer, if anyone objected we would abstain from this practice at tonight's meeting. No one objected, Mayor asked Mr. Nelson to open with prayer.

Mayor stated the reason for the road would be to help with the traffic during funerals and Frontier Days, and Home Coming at the churches. They are in agreement to the road if it is blocked during all other times. Mayor stated we would take this under consideration.
