Mr. Fowler reported that the pandemic guidelines can be enforced. It would be a misdemeanor. They can arrest if they continue to disobey the guidelines.

Old Business:

The renovations to the front of the Town Hall were discussed. There isn't a rendering of what it would look like. Mayor Livingston will check with Mr. Dunn to see what he is going to do.

Hauling equipment was discussed. It would cost \$250 to put electric brakes on the blade truck.

Purchasing a 1-ton truck dump truck was discussed.

Mayor Livingston discussed the need to check on a new mower and purchase one soon. The present mower is 22 years old.

Mayor Livingston reported that he had called Karen Alexander Blair to let her know the Town was not interested in purchasing the land next to the sewer plant at the price they quoted.

Flooding in the storm shelters was discussed. Mayor Livingston reported that Jeff Frost is trying to come up with a solution.

Mr. Chambers made a motion to approve the bills, Mr. Persall 2nd, motion carried.
