

Minutes of the regular meeting of the Eva Town Council held on 9 February 2021 at 6:30 PM at the Eva Town Hall. Present: Mayor Gary Livingston, Council Members: Kent Chambers, Johnny Persall, Martin Nelson, Edsel Childers, Ripley Fowler, and Town Clerk Kathy Nelson. Guests: Greg Holmes and Joey Sides

Mayor called the meeting to order; all present. After roll call Mayor Livingston informed all present that we open our meetings with prayer, if anyone objects, we will abstain from this practice at tonight's meeting. No one objected, Mayor Livingston asked Mr. Nelson to lead us in prayer.
