

Minutes of Call Meeting of Eva Town Council held in special session June 23, 1984, at 9 a.m., attended by Mayor Ryan, Councilmen Nichols, Livingston, Page and Hipps.

Mayor stated purpose of the meeting was to make plans for extending the city limits. Council voted to incorporate 24 plots, which includes 21-40's and 3-20's, as marked on map used in the meeting. (Motion Nichols; Second Hipps; carried). Mayor stated that this will more than double the size of the present incorporated limits of Eva. Amount to be taken in is 900 acres. *

While in session, the Council voted to declare the persons who qualified (only one per office as certified by the Mayor and Clerk) as duly elected by Resolution 84-2, adopted per motion of Mr. Livingston; second by Mr. Page (carried).

There being no further business, Mr. Nichols offered the motion, seconded by Mr. Page that the meeting be adjourned.

RESOLUTION 84-2

WHEREAS, Sections 11-46-20 through 11-46-73 of the Alabama Code of 1975, as amended, provide for and regulate general and special elections in cities and towns of this state, except those cities and towns which have a Commission form of government, and

WHEREAS, Section 11-46-26 of the Alabama Code of 1975, as amended, provides that if only one person has filed a statement of candidacy or has been nominated for an office for an election to be held pursuant to Sections 11-46-20 through 11-46-73 of the Alabama Code of 1975, as amended, at the time the deadline for qualification has passed, then such person shall, for all purposes, be deemed elected to such office, and the Mayor or other chief executive officer shall immediately file a statement with the governing body of the municipality, attested by the Clerk, certifying the fact that only one person filed a statement of candidacy or was nominated for the office preceding the deadline set for an election of municipal officers of the municipality and setting forth the name of such person or persons, and

WHEREAS, said Section 11-46-26, as amended, provides that the governing body of the municipality shall adopt a resolution declaring the person or persons named as duly elected to the respective office or offices, and

WHEREAS, the Mayor of the Town of Eva has stated to the governing body of the municipality, attested by the Clerk, that only one person filed a statement of candidacy for the offices listed below prior to the deadline established in the notice of election, and that the name of that person who filed such statement is given below by the respective office for which he qualified,

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Eva, Alabama, that these persons be and are hereby declared duly elected to the offices given in the Town of Eva for the term of office commencing on the first Monday in October, 1984.
