

Minutes of the regular meeting of the Eva Town Council held on June 10, 2003, at 6:30 p.m. in the Eva Town Hall. Present: Mayor Gary Livingston, Council members: Clarence Alexander, Bert Collins, Kent Chambers, Brian Brown, C. C. Mosteller and Clerk Judy Fortenberry.

Guest: Deputy Campbell

After roll call Mayor Livingston call the meeting to order and asked Mr. Collins to open the meeting with prayer.

Mayor Livingston asked if everyone had read minutes of the May 13, 2003, regular council meeting. Mr. Collins motion to approve, Mr. Alexander seconded, carried.

A. FINANCE & EDUCATION - MR. MOSTELLER

Mr. Mosteller presented and motion to accept the revised 2002-2003 Budget with the following changes: \$500 from 4100 – School Support, \$2,000 from 4150 – Travel, Conferences & Meetings, \$2,500 to 4110 Roads and Streets, Mr. Collins second, carried.

Mr. Brown will get with Mr. Stisher and confirm the Town of Eva's share of the road in front of the school.

B. UTILITIES – MR. ALEXANDER

Mr. Alexander reported the septic tank at the Center should be checked to see if water is running into the tank, this may be the problem we are having. Clerk to get with Joe Hill and have him dig up the tank and check.

Requested Fire Department to check Ryan Road for additional fire hydrant requirements, if needed then Town should install.

C. STREETS, PARKS, & CEMETERIES – Mr. BROWN

Mr. Alexander reported that the icemaker purchased from Mr. Kitchens is up and running. Old icemaker will be transferred to fire department. Brown reported the entrance to Ryan Road should be widened, and wanted to know the distance from the centerline for right-of-way. Mr. Alexander reported that the road could not be widened due to the church parking lot.

Clerk reported lawn mower at the park needs two tires on the front, Mayor requested that Mr. Shaver take the tires to Eva Tire if tires are needed then purchase.

D. POLICE & FIRE – MR CHAMBERS

Mr. Chambers reported rescue tool is due within the next two weeks.

Deputy Campbell reported no problems.

E. RECREATION & SANITATION – MR. COLLINS

Mr. Collins presented to the Council the contract from Ladd Environmental for the Sewer Project, and motion to have Larry Madison, Town of Eva Attorney to look over before having the Mayor sign, Mr. Chamber second, carried.
