

Minutes of Call meeting of Eva Town Council held September 21, 1990, at 7 p.m., attended by Mayor and all five members of the Council. The meeting was opened with prayer by Mr. Page:

The Mayor stated that the reason for the special meeting is to discuss additional things to be done for the walking trail and to approve resolutions needed on file in case of audit on the Walking Trail.

Old Business:

1. Walking Trail: The walking trail is completed and payments have been made. However, there are some things that need to be done in order to protect the Walking Trail from damage. The Mayor asked the responsible Councilmen to be sure that proper signs are up stating that the Trail is for walking only and no motorized vehicles, etc., will be allowed. Poles need to be put up in order to keep cars off the trail. Signs also need to be made stating the length of each trail. Motion made by Mr. Collins, second by Mr. Livingston (carried) to authorize the Park Council to purchase whatever materials are needed, regardless of price, to protect the trail.
2. Budget:
 - a) FY1990-91 School Budget presented with corrections. The total budget is now \$9982.00. Motion made by Mr. Page, second by Mr. Collins (carried) to approved Budget as presented.
3. Resolution presented for new signatures on all Bank accounts. Motion by Mr. Page, Second by Mr. Livingston (carried) for the accounts to remain in effect with only 1 signature rather than 2.
4. Road Requirements: Road Council Committee to look over specs. and report back at a later date.
5. Census:
Proper paperwork being done by Town Clerk for census challenge.

New Business:

1. Motion by Mr. Page, Second by Mr. Morgan (carried) to adopt Resolution 90-7 concerning Equal Employment Opportunity Officer.
2. Motion by Mr. Collins, second by Mr. Morgan (carried) to adopt Resolution 90-8 concerning Standards of Conduct for Federally Funded Contracts.
3. Motion made by Mr. Nichols, second by Mr. Livingston (carried) to adopt Resolution 90-9 concerning Fair Housing Activities for the Town of Eva.
4. Motion made by Mr. Livingston, second by Mr. Collins (carried) to adopt Resolution 90-10 concerning purchasing procedures for the Town of Eva.
5. Band Boosters Request to sell chances in front of City Hall during Pioneer Days: Mr. Nichols suggested that we need to have a policy concerning ticket (chance) sales. After some discussion, a motion was made by Mr. Collins, second by Mr. Nichols (carried) not allowing any group to

- sell tickets (chances) on any City property.
6. John Smith's request for gravel: Mr. Smith requested gravel due to new schoolbus routing. Town Clerk to contact County Board Transportation Department and investigate further.
 7. Ribbon-cutting for Walking Trail: Motion by Mr. Page, second by Mr. Livingston (carried) to set the first week of October for Ribbon Cutting Ceremony. Town Clerk to work out details and contact officials in Montgomery and Decatur.
 8. Authorization for payment of bills: Motion made by Mr. Livingston, second by Mr. Morgan (carried) to pay bills as submitted. Motion by Mr. Collins, second by Mr. Livingston (carried) to transfer funds as requested.
 9. Budget Request from Morgan County Rescue Squad: Motion made by Mr. Collins, second by Mr. Morgan (carried) to approve Budget for Rescue Squad as submitted.

Motion by Mr. Livingston, second by Mr. Nichols (carried) to adjourn.
