

Agenda - Eva Town Council Meeting - Sept. 10, 1987

Old Business:

- 1 - Our grant request from Land & Water for park development was not approved.
- 2 - Blueprints/specs have been given to the following potential bidders for addition; Mike Hopper, Claude Bailey & Son, Benny Childers and Genesis Construction Co. of Decatur (Bill Wood). When do you want to open bids? I need to let them know so they can get the bids back in.  
Get Williams to shoot the line on lower side to make sure we're still on town property for addition?
- 3 - Did anyone talk to Billy Roberts about the front door at the Center?

New Business:

- 1 - Clerk needs to take her typing table she's using (personal property) back home; other one at home tore up. Will Council approve purchase of a typing table from L&N (estimated cost \$39)?
- 2 - Site needs 2 more tables. L&N Office Supply prices are the following:  
8' - second - \$49 ea. (This is the kind we got before.)  
6' - second - \$34.50 ea.  
6' - first quality - \$49 ea.
- 3 - VFD members are asking about the annual barbecue; whether the Council will have one for them and other town volunteers (Librarians) as usual in October. If so, they will get their wives to fix the potato salad, baked beans and desserts. Last year's BBQ from Whitt's for the party cost \$144.94 (30# BBQ; 2 gal. slaw) The Fireman-of-the-Year plaque cost \$10.  
Suggested dates: Oct. 3, 6:30 PM or Oct. 10, 6:30 PM.
- 4 - Glen's Garbage Service lost the county contract to BFI, who takes over service in the county Oct. 1. Glen's can continue picking up in Eva town limits, and hopes everyone will stay on as his customers. However, the residents in town have the option of staying with Glen's or subscribing to BFI. BFI rates will be \$5.69 per month for residences, with 1 month's pay in advance. You have to call BFI (739-0918) to have them send you the paper to fill out and return with your month's pay; then they send you a sticker. BFI would like to put a dumpster at the Senior Center at a charge of \$28/month. Glen's would continue picking up at the usual fee until Jan. 1, but he said he might have to go up to \$15 month at Senior Center since they have so much garbage each week. Council needs to vote whether to stay with Glen, or have BFI take over service. If BFI, would they be willing to pay the \$28/mo. for a dumpster?
- 5 - Town Hall needs another good cleaning. When Edith Poole cleaned about 2 months ago, we paid her the \$3.65 an hour which is what we started out paying her two years ago. She said she would like a little raise on that if she cleans again. She usually gets \$5 an hour to clean. What is the Council's wishes?
- 6 - Any word from Mr. Mulder at Hartselle Medical Center on changes to be made at the Clinic? He said to hold up on the mailout until he had more figured out on what changes will be made. Said he'd contact the Mayor when he had things lined up.
- 7 - What will we do about the Rt. 1 Falkville petition?
