

Minutes of called meeting of the Eva Town Council held on September 22, 1997, at 9:00 A.M. in the Eva Town Hall. Present: Mayor Livingston, James Fowler, Clarence Alexander, Larry Smith and Bert Collins. C. C. Mosteller was absent due to family commitment.

After roll call, Mayor advised that purpose of meeting was to adopt Ordinance #97-2 Sale of Unneeded Property, Ordinance # 97-3 Sales of Unneeded Property, and Ordinance # 1(4) As Amended. Also, discuss one-cent sale tax.

Ordinance # 1 (4) As Amended to Section 7 was introduced by Councilmember Alexander. Councilmember Smith moved that all rules governing the council which might, unless suspended, prevent the passage and adoption of the ordinance at this meeting, be and the same are hereby suspended for the purpose of permitting the said ordinance to be finally passed and adopted at this meeting. Councilmember Fowler seconded this motion. On roll call vote follows:

Mayor advised that he was ask about selling top soil which needs to be moved from the Industrial Park, following discussion, Mr. Fowler made motion to sell top soil at \$.50 per yard, Mr. Collins second, carried. -

Mayor then advised it will probably be November 1 before one-sent sale tax ordinance can be in place. When the ordinance is completed by the attorney, he will call a meeting.

Mr. Smith made motion to adjourn, Mr. Alexander second, carried.
