

COUNCIL MEETING 10-8-87

Old business:

- 1-Filed Letter of Intent with Land & Water to apply for grant again this year.
- 2-Property to Chaffins finalized.
- 3-Mayor talk with Mr. Summerford about new Stop signs, and signs for 4-way stop (proposed by Martin Nelson? Can they do them in-house?)
- 4-No word yet from Justice Dept. on annexation.
- 5-Door at Senior Center installed; had to be painted (Mitchell did); looks good.
- 6-Charles Ford will not bill us until he gets back out here to replace the 2 dead shrubs. Other work finished, but he will bill for all of it at one time.
- 7-Bill Nelson has been down in his back, but will plan to install the outdoor faucet(s) at the Center next week. Could Mitchell be at the Center Monday morning between 9 and 10 to show him the location or locations, and where the water lines are?
- 8-Mr. Mulder said today that he didn't have a definite answer from the doctor yet. He is anxious for Mayor to call him to let him know what he thought about the building (double-wide) in Texas; about moving it here; location, etc.
- 9-No word yet from Mr. Jones on bids for playground equipment, landscaping, etc.
- 10-Clerk has not learned any more about the 'computer books; will try to find out something by Sat. night's meeting.

New business:

- 1-Seth Ballew wants a letter from Town of Eva saying that the Council wants Ballew Sanitation to pick up the garbage within the corporate limits of Eva.
- 2-Wayne Maples (lives between Lowe & Alexander around Murphree Road) requested to get the County out to dig a longer trench so that it would stop washing his driveway out whenever it rains; also to cut the high grass at Lowe's corner; dangerous for drivers. Reported this to Mayor and Mr. Nichols. Any action? (Maples 796-7803)
- 3-Could we hire Tim Newman to weedeat around hydrants and stop signs; banks? ✓
- 4-Terrell Industries (Mr. Watts 773-1922), a sheltered workshop for mentally retarded, is being built in Hartselle. Things are going satisfactorily, but in order for them to get equipment and set up for operation, and until they can become self-serving, they are asking businesses and municipalities to make a 3-year commitment, saying that by that time everything should be operating satisfactorily without further help. They are asking if the Town of Eva will commit \$100 or \$125 for 3 years, payable beginning of each fiscal year.
- 5-Decide where to put up the 2 signs; buy 2 more?

- 7-ISO rating came in; with Class 7/9 (formerly 8/9).
- 8-Received Termination notice from Joe Wheeler re electricity at Clinic; \$139.10 past due. Should Town pay it this month if they aren't going to; to keep power out there? Their phone is connected through electricity some how.
