

Minutes of called meeting of Eva Town Council held on November 30, 1994, at 1:00 pm in the Eva Town Hall. Present: Mayor Livingston, Afton Fowler, Larry Smith, Bert Collins, Charles Nichols and Firechief Holmes.

Purpose of meeting to appoint new Firechief for retiring E. A. Holmes, J appoint three board members to Eva Industrial Development Board, discuss issuance fees for privilege license and Workman's Compensation Insurance for employees.

Mayor advised that it had come to Clerk's attention there was no Workman's Comp insurance for Town of Eva employees. Rate for one year is \$750.00 for clerk and maintenance and \$900.00 to include Mayor/Council. Mr. Nichols made motion to take insurance for clerk and maintenance only at \$750.00 annual premium, Mr. Smith second, carried. (Insurance through Hill Insurance of League of Municipalities)

After lengthy discussion on issuance fees and privilege license, Mayor suggested would probably need to raise issuance fees for 1995 and set a work session in early 1995 to discuss changing the method of charging privilege license fees. He also mentioned that the new Alabama Code Act 94-644 increases the issuance fee for privilege licenses to \$5.00. Mr. Collins made motion to increase issuance fee to \$5.00, Fowler second, carried. Mayor advised clerk to amend license to present at regular council meeting December 6, 1994.

Mayor advised council that he would like to recommend John Alderman, Jim Nix and William Neal to replace expired terms on Eva Industrial Development Board. Mr. Smith made motion to accept this recommendation Mr. Fowler second, carried.

Mayor advised council that Firechief E. A. Holmes, Jr., had announced his retirement effective January 1, 1995. Councilman Smith made recommendation of Dennis Holmes because of his knowledge with the equipment and training, Mr. Fowler second, carried. Effective date for Dennis Holmes, Firechief would be January 2, 1995.

Mr. Smith made motion to adjourn, Mr. Collins, second, carried.
