A. Finance & Education - Mr. Masteller

1. Motion to reinvest C.D. #4561 - Mr. Livingston  
will check w/ banks.
2. Contracting procedures for Library - Mr. Livingston  
reported that we can spend up to \$50,000 w/out  
going out for bids. This was covered in a  
session at the Pl. Mung. League meeting in Apr.
3. Mayor announced that State has given the  
Town a grant for \$10,000. for the library. Clerk  
will fill out required paper work and fax  
to State on 5/12/99.

B. Utilities - Mr. Alford

1. Water tank adjacent to his property has not been  
taken care of.

Century - Reiby Frost dug out a <sup>small</sup> ~~little~~ section  
and more water came out. Reiby will come

back dig out old drain and install new pipes

Mr. Fingleton mention that he had talked to Don Stiche, about the water system. Mr. Stiche will have a man come out and look at our water system at no charge. Mr. Stiche is looking at pushing the water system for Morgan County.

C. Stueck, Parks & Cemeteries - Mr. Fowler.
