

Called meeting of the Eva Town Council August 22, 2000, 7:30 p.m. at the Eva Town Hall.
Present: Mayor Gary Livingston, C. C. Mosteller, James Afton Fowler, Clarence Alexander,
Larry Smith, Bert Collins, and Judy Fortenberry. Guest: Brain Brown.

The meeting was called to order by Mayor Livingston, the purpose of the meeting was to canvass returns for the election held on August 22, 2000. Council Place No. 3 was the only place oppose during the general election: Votes were:

Mayor declared that Brian Brown received a majority of the votes cast for the office of Councilmember Place No. 3 and is hereby duly elected to that office for the term beginning on the first Monday in October 2000.

Resolution 00-12 Canvass Resolution was introduced by Councilmember Collins and read at length.

Councilmember Fowler moved that all rules governing the council which might, unless suspended, prevent the passage and adoption of the resolution at this meeting, be and the same are hereby suspended for the purpose of permitting the said resolution to be finally passed and adopted at this meeting.

Councilmember Alexander seconded this motion.

The question was put before the council and on roll call the vote was as follows:
