## Investment Objective

To provide a minimum of 8% p.a after fees over rolling 3-year periods comprising both income and capital growth.

## Investment Strategy

The fund will make investments into a diversified portfolio of listed and unlisted assets, including domestic and international Equities, Fixed Income, Property, Alternatives, and Cash.

The funds overarching investment philosophy is primarily driven by a belief in active, and fundamental portfolio management. The inefficiency of markets at both the macro and micro level cause price dislocations, providing an investor with a competitive advantage and compelling investment entry and exit points across the business cycle.

Rajomon investment strategy has a strong focus on risk management, with the direction and allocation of the risk budget seen as crucial to ensure that the fund is exposed to investments that provide the greatest alpha opportunities for the least amount of risk taken. Diversification is seen as key to the management of risk, which is complemented by optimal portfolio construction both at the asset class and the sector level.




