- VII. Presentation of two sets of audited accounts (both audited and consolidated).
- VIII. Ordinary Resolution: Receipt and approval of both the Audited Financial Statements and the Audited Consolidated Financial Statements of SAMARA ASSET GROUP PLC (Annual Report) of the Company for the year ended 31st December 2023 and the Directors' Report for the year ending 31st December 2023 and the Auditors' Report for the year ending 31st December 2023.
- IX. **Ordinary Resolution:** To appoint the auditors of the Company and to authorise the Board of Directors to fix their remuneration.
- X. **Ordinary Resolution:** The resignation of Dr Joerg Werner as Director of the Company and the election and composition of the new Board of Directors of the Company.
- XI. **Ordinary Resolution:** Determination of the fees for the members of the Board of Directors and the Chief Executive Officer (CEO).
