This is a summary of the annual report of the Singleton Associates, P.A. Health & Welfare Plan, EIN 74-1680498, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Singleton Associates, P.A. has committed itself to pay certain self-insured Medical, Dental, and Vision claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Metlife Legal Plans, Hawaii Medical Service Association, 98point6, Modern Health Arizona P.L.L.C., Premera, Metropolitan General Insurance Company, Metropolitan Life Insurance Company to pay Medical, Dental, Vision, Employee Assistance Program, Legal, Critical Illness, Hospital, Telehealth, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$124,924.
