Revenue Model Analysis

Platform Fee

10% of all profits

- Base Case: \$100M daily volume
 - → \$365M annual platform fees
- Bull Case: \$500M daily volume →
 \$1.83B annual platform fees

Token Appreciation

Initial \$400M market cap with 10B tokens locked

- Volume-driven unlock mechanism creates scarcity
- Utility demand from agent creation and graduation



- Agent Creation: Required stake
- Graduation Fee: \$1,000 minimum PAI

- Total Supply: 10B PAI tokens
- Initial Lock: 100% at \$400M valuation (\$0.04/token)
- Unlock Mechanism: Volumebased (1% per \$10M daily volume)

Price Projections

- Conservative: \$0.20 (5x from launch)
