You can control or disable cookies through your web browser's cookie settings. Most browsers allow you to refuse the acceptance of cookies, delete existing cookies, or receive a notification before a cookie is stored. Please note that disabling cookies may affect the functionality of the Site and some features may not operate correctly. For more detailed instructions on how to manage cookies in your browser, consult your browser's help documentation.

Where required by law, LogoPop will obtain your explicit consent before placing non-essential cookies on your device. A cookie banner or pop-up may appear upon your first visit to the Site to inform you of our cookie practices and allow you to manage your preferences.

Information collected through cookies is treated in accordance with our Privacy Policy. We do not use cookies to access personal information on your device, nor do we use cookies to install malware or harmful code.

We reserve the right to update or modify this Cookie Policy at any time, without prior notice. Any changes will become effective upon posting of the updated policy on the Site. Your continued use of the Site following such changes constitutes your acceptance of the revised Policy. We encourage you to review this Policy periodically to stay informed about how we use cookies.
