

Limited Lifetime Warranty

WARRANTY COVERAGE

Artiza Cabinetry LLC (“Artiza”) is proud to offer the following limited warranty to the original residential purchaser of all cabinets imported, assembled, and sold within the United States by Artiza. This warranty is not applicable to cabinets sold or shipped outside the United States and Canada. A residential purchaser is defined as an individual who purchases and installs the cabinets in a residence that is personally owned and used as a primary or secondary home. In cases involving developers or builders, this limited warranty can be transferred to the initial homebuyer who utilizes the residence as a primary or secondary dwelling. However, this warranty is non-transferable to subsequent homeowners. This limited warranty is governed by all limitations, exclusions, disclaimers, and procedures outlined herein.

LIMITED LIFETIME WARRANTY

Artiza provides a warranty to the original consumer purchaser that all cabinets purchased from Artiza will be free from unnatural defects in materials and workmanship under normal residential use, as long as the original purchaser owns the home where the cabinets are installed, in accordance with the Artiza quality standards.

EXCLUSIONS

This warranty replaces all previous warranties provided by Artiza and is the sole remedy for all defects, damages, and workmanship issues. No implied warranties extend beyond the terms of this warranty. To the fullest extent allowed by law, Artiza will not be liable for any indirect, special, punitive, incidental, or consequential costs, expenses, or

damages (including lost profits), even if this limited lifetime warranty is deemed to have failed its essential purpose. Certain states do not permit the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty provides specific legal rights, and you may have other rights that vary from state to state. It is possible that one or more of the limitations or exclusions in this warranty may not apply to you.

LIMITATIONS

This warranty will become void if the cabinets, hardware, drawer slides, or hinges are modified from their original form, improperly installed, or damaged before or during installation, or used for purposes other than residential. This warranty covers only the parts and materials of the cabinets as supplied by Artiza. It does not cover any products used or installed in connection with the cabinets, such as appliances, countertops, or plumbing fixtures. Additionally, this warranty does not apply to products installed in environments without year-round climate control. This warranty does not cover damages caused by transportation, storage, dirt, chemicals, moisture, humidity, extreme temperatures, normal wear and tear, misuse, neglect, accidents, alterations, improper use, improper maintenance, house settling, or acts of nature. No installer, retailer, distributor, agent, or employee of Artiza is authorized to modify the obligations or limitations in this warranty.

WARRANTY PERFORMANCE

If a defect arises within the terms and conditions of this warranty, Artiza will, at its

sole discretion, repair or replace the defective part. Artiza will not cover the costs of removing the defective product, transporting the defective, repaired, or replaced product, or installing the repaired or replaced product. If repair or replacement of a defective product is not commercially feasible, we may offer a refund of the original purchase price or provide a credit towards a similar product from our inventory. Artiza is not responsible for any shipping damage to defective, replaced, or repaired products. If the defective item has been discontinued or is unavailable at the time of the claim, Artiza reserves the right to replace it with the most similar item available in our inventory at that time. Artiza reserves the right to alter the design, specifications, and materials without any obligation to apply these changes to previously manufactured products. Due to the natural aging process of wood and finishes, Artiza cannot guarantee that the finish of any replacement will exactly match the finish and appearance of the defective item. At our discretion, we may require the customer to submit a clear photo or have a company representative inspect the claimed item before honoring this warranty.
