DO YOU HAVE A SURCHARGE?

A 10% service charge applies to the minimum spend for private events. This is shared across the Park & Cove team delivering your event.

STYLING AND DECOR

Additional styling is welcome, including florals, signage and table décor. Please confirm any arrangements with your Event Manager prior to the event.

RSA

Responsible Service of Alcohol applies at all times. Last drinks will be called 30 minutes before the event concludes. Shots and double pours may be limited later in the evening.

CAN I DELIVER ITEMS BEFORE MY EVENT?

Items may be delivered on the day of your event with prior approval from your Event Manager. Please ensure all deliveries are clearly labelled.

DO YOU SPLIT BILLS?

We prefer a single payment for group events. If required, the total can be split evenly across a small number of cards.

ENTERTAINMENT

A Park & Cove background playlist will play throughout your event. With exclusive venue hire, you may provide your own music with approval from your Event Manager.

CAN I BRING A CAKE TO MY EVENT?

Yes, you are welcome to bring a cake. Plates and cutlery will be provided. A 40 cakeage fee applies.

DO YOU CATER FOR DIETARY REQUIREMENTS?

Yes. Please advise your Event Manager of any dietary requirements prior to the event so our chefs can prepare accordingly.

WHAT AV EQUIPMENT IS AVAILABLE?

Basic equipment can be arranged. For additional AV needs, please speak with your Event Manager. Microphones are available with exclusive venue hire. Fees apply.

DO YOU HAVE A SMOKING AREA?

Park & Cove is a non-smoking venue. Guests may use designated outdoor smoking areas within the resort.

Terms & Conditions

Introduction

To assist in delivering your event smoothly, please review the following Terms & Conditions. Confirmation of your booking with Park & Cove at Peppers Noosa Resort & Villas indicates acceptance of these terms.

Reservations & Confirmation

All reservations require valid credit card details at the time of booking to secure the date. Bookings must be confirmed within the timeframe advised by management. Failure to meet confirmation requirements may result in the booking being released without notice.

Deposit & Payment Terms

A non-refundable 30% deposit (based on the minimum spend requirement) is required within 7 days of confirmation to secure your reservation. Final payment of the remaining balance is required no later than 14 days prior to the event date. Payments can be made via EFT or credit card. A 1.4% credit card surcharge applies.

Cancellation Policy

All cancellations must be advised in writing. More than 30 days prior – deposit forfeited as cancellation fee. Within 30 days – 100% of the contracted value payable.

Event Hours

Event times must be confirmed in advance and strictly adhered to. Standard event times are lunch functions 12:00pm – 4:00pm and evening functions 4:30pm – 12:00am. Events running beyond the agreed time may incur additional staffing charges.

Music & Entertainment

External DJs or musicians may be arranged with prior approval from management. Music must comply with venue licensing and local authority requirements. All music must conclude by 10:00pm. Decibel limits apply.

Final Arrangements & Event Details

Final event details must be confirmed no later than 14 days prior to the event and include food and beverage selections, final guest numbers, supplier list, special requests and final payment.

Final Numbers

Confirmed final guest numbers must be provided 14 days prior to the event and will be the minimum number charged.

Commencement & Vacation

Clients and guests must arrive and vacate the venue within the contracted event times.

Liquor & Beverages

All beverages are supplied exclusively by Park & Cove. Responsible Service of Alcohol laws apply at all times.

External Food & Beverage

External food or beverage is not permitted without prior written approval. A cakeage fee applies to externally supplied cakes.

Dietary Requirements

Dietary requirements must be advised no later than 14 days prior to the event.

Insurance & Liability

Park & Cove does not accept responsibility for loss, damage or theft of personal belongings.

Damage

Clients are responsible for any damage caused to the venue, furnishings or equipment by themselves, guests or suppliers.

Deliveries & Collection

Deliveries may occur on the day of the event unless otherwise arranged. All items must be collected immediately after the event unless prior approval is provided.

Price Variation

Prices may be subject to change without notice. Bookings made more than 6 months in advance may incur price adjustments.
