Position Overview

The Karuk Tribe, through the Karuk Tribe Housing Authority (KTHA), invites applications for a qualified **CURRICULUM FACILITATOR** for the *Healing of the Canoe – Wisdom Keepers Program*, serving Native youth in grades 4 through 8. This individual will lead the implementation of the curriculum at Junction Elementary, coordinating with the Cultural Practitioner to deliver all sessions and maintain program quality. The Kahtíshraam Wellness Center team will provide guidance, materials, and ongoing support.

Program Description

Healing of the Canoe – Wisdom Keepers is a cultural wellness program that helps Native youth build life skills, resilience, and a strong sense of identity. Guided by the Pacific Northwest Canoe Journey, it teaches healthy choices and cultural pride through Karuk dances, values, and traditions.

The program includes 14 sessions scheduled with school staff. The Curriculum Facilitator and Cultural Practitioner will work together to create a safe, engaging, and culturally rich space for learning and connection. All materials are provided through grant funding. The project rate is \$4,000, payable in one lump sum at completion or in two installments after required paperwork is submitted.

Roles and Responsibilities

The Curriculum Facilitator will:

- Deliver all Healing of the Canoe sessions on schedule and with preparation.
- Work closely with the Cultural Practitioner to complete cultural projects.
- Maintain accurate attendance and required documentation.
- Create a safe and respectful space that supports youth learning and growth.
- Communicate progress and needs regularly with the Wellness Center Director.

The facilitator will lead on-site sessions and ensure smooth delivery. The Kahtíshraam Wellness Center team will provide materials, scheduling support, and ongoing guidance.
