## **Notes From The Chairman**

yukii, koovura,

Hope all is well in Indian Country! I recently attended the Tribal Nations White House Summit in Washington DC. President Biden and Vice-President Harris were both in attendance. The Biden-Harris administration has implemented groundbreaking legislation like the American Rescue Plan, the Bipartisan Infrastructure Law, and the Inflation Reduction Act. They are making historic investments in Indian Country, including billions of dollars to rebuild infrastructure, improve internet access, ensure clean drinking water, combat climate change and create good paying jobs.

Here are some of the significant accomplishments the Federal Government has made for Indian Country:

- Took significant steps to improve consultation with Tribes.
- Continued to appoint Native Americans to Federal Government positions in record numbers.
- Sent Federal Government officials out to visit Tribal Councils.
- Continued championing innovative co-stewardship and co-management agreements to ensure Tribal Nations have a role—and can bring their valuable knowledge and expertise—to federal land management.
- Worked to ensure federal employees understand and respect Tribal treaty and sacred site rights.
- Centered environmental justice and Tribal priorities in our approach to conserving and protecting our Nation's land and natural resources.
- Fought for unprecedented levels of funding for Indian Country—including securing reliable advanced funding for Indian Health Service for the first time in history.
- Took bold steps to make federal funding more accessible to Tribal Nations.
- Expanded the Federal Government's efforts to buy from Native—owned businesses.
- Successfully defended one of Indian Country's most precious laws, the Indian Child Welfare Act, before the United States Supreme Court.
- Expanded broadband infrastructure to bring internet to more Native homes.

In summary, the work documented in these reports are extensive—reflecting the Biden—Harris Administration's deep commitment to Indian Country. President Biden is committed to delivering on policies that will make things better for Native communities. Policies that will protect what is most precious to Tribal communities from their Children and Elders to their Languages and Culture. This administration is dedicated to championing a new era of the Nation-to-Nation relationship with Tribal Nations and one where Tribal Nations are, above all, respected as the sovereigns that they are.

#### On the home front:

Of particular interest to the Karuk Tribe is securing co-management agreements to manage the lands in our aboriginal territories. Currently these lands are managed by the United States Forest Service. The Karuk Tribal Council will be asking for equitable funding to implement Tribal Ecological Knowledge into the management process. Funds for trainings, equipment, vehicles, workforce housing, and economic development.


I would like to give special things to Erin Hillman for her work on getting the funding and organizing the food distribution for the elders, as well as a yootva to KTHA Wellness Center staff in Happy Camp and Yreka for helping to set up the distributions. A special shout out to Jack Lantz, Tribal Public Works Director who has put so much time in developing a community farm in the Yreka next to the Elders Community in Housing. The farm in Yreka is coming along nicely and will be ready to plant by Spring. A future project that the Tribe will be working on is to develop our own organic seed bank to help sustain our community gardens. All three areas Orleans, Happy Camp and Yreka will benefit.

I also would like everyone to know that the Rain Rock Hotel and Casino expansion is moving along on schedule. The Casino expansion should be ready by the end of April. It will include a completely non-smoking section, which is truly exciting for our non-smoking customers. The hotel grand opening will be sometime in June, more likely towards the end of June.

I also would like to express how honored that I am to have worked for over twenty years for the Karuk Fisheries Department to bring down Klamath dams. This celebration belongs to many organizations and people who are dedicated their lives to saving the Klamath, River, and the people who live there. It will be amazing to see the salmon migrate all the way up back up into Oregon again. The salmon is the way of life for our people.

I will continue to work hard to regain are inherit right to manage our ancestral lands. who better than Native American people to take care of the land? It is in our DNA to take care of our mother Earth.

## Winter Weather Safety Tips

proving to be a bit more challenging this year. Take the time to prepare your family. Stay home, do not drive during a storm.

#### **Outside:**

- Pick-up hazards you may not see covered in snow
- Place cardboard over car windows
- Take your time when walking outside in shoes with solid treads
- Move your wood or pellets closer to your door
- Have salt, shovel, and broom on hand to clear
  - Pathways
  - Animals shelters
  - Other shelters with weak roofs
  - Satellite Dish

#### Inside:

Your primary concerns at home or work during a winter storm are loss of heat, power and telephone service and a shortage of supplies if storm conditions continue for more than a day. In either place, you should have available:

- Flashlight and extra batteries
- Battery-powered NOAA Weather Radio and portable radio to receive emergency information
- Extra food and water such as dried fruit, nuts, granola bars and other food requiring no cooking or refrigeration.
- Extra prescription medicine
- · Baby items such as diapers and formula
- First-aid supplies
- Heating fuel: refuel before you are empty; fuel carriers may not reach you for days after a winter storm
- Emergency heat source: fireplace, wood stove or space heater properly ventilated to prevent a fire
- Fire extinguisher, smoke alarm; test smoke alarms monthly to ensure they work properly
- Extra pet food and warm shelter for pets
- Review generator safety: Never run a generator in an enclosed space such as your house
- Make sure your carbon monoxide detector is working correctly and that the outside vent is clear of leaves and debris. During or after the storm, make sure it is cleared of snow.
- Home fires are common each winter when trying to stay warm. Review ways to keep your home and loved ones safe.

#### Vehicle:

Each year, on average, more than 5,000 people are killed and more than 418,000 are injured due to weather-related vehicle crashes. If you need to drive in snow or cold

conditions, TAKE IT SLOW IN THE SNOW. Black ice can be difficult to see. If the temperature is near freezing, drive like you're on ice--you may be!

Before you leave the house, especially before a longer trip in winter, make sure all fluid levels are full and ensure that the lights, heater and windshield wipers are in proper condition. Keep your gas tank near full to avoid ice in the tank and fuel lines. Avoid traveling alone. Let someone know your timetable and primary and alternate routes. Then call 511 for the latest traffic and road incidents, including construction and weather conditions and restrictions. Every state offers this Department of Transportation service. Call before you leave; it might change your plans!

- Fully check and winterize your vehicle before the winter season begins. Carry a Winter Storm Survival Kit that includes the following:
- Mobile phone, charger, batteries
- Blankets/sleeping bags
- Flashlight with extra batteries
- First-aid kit
- Knife
- High-calorie, non-perishable food
- Extra clothing to keep dry
- Large empty can to use as emergency toilet, tissues, toilet paper and paper towels
- Small can and waterproof matches to melt snow for drinking water
- Sack of sand or cat litter for traction
- Shovel
- Windshield scraper and brush
- Tool kit
- Tow rope
- Battery booster cables
- Water container
- Candle and matches to provide light and in an emergency, lifesaving heat.
- Compass and road maps, don't depend on mobile devices with limited battery life

#### **Outside Animals**

- Move animals to sheltered areas or bring pets inside.
   Shelter belts, properly laid out and oriented, are better protection for cattle than confining shelters, such as sheds.
- Haul extra feed to nearby feeding areas.
- Have water available. Most animals die from dehydration in winter storms.
- Make sure pets have plenty of food and water and a warm shelter

## **Emergency Services Department Update**

December marks a full year of serving the Karuk Tribe as your Emergency Manager. It has been quite a year and entering into 2024, I believe it will be equally busy for me as I continue to improve the Tribes Emergency Preparedness Department. Some of the highlights of this past year included teaching First Aid and CPR to employees, community members, medical staff, and even contractors for the new medical and dental clinics and the dam removal crew at Copco and Irongate on the upper Klamath River. We have several classes coming up in January and will continue through Spring and Summer. I will be providing the AVERT Training (Active Violence Emergency Response Training) to all departments and going over emergency action plans for all of





During the height of the wildfire season of 2023 I was working in the field and spent 21 days straight working, starting with the Head fire, assisting our Federal, State, and County partners with emergency evacuations, road blocks, and response to tribal members who were in need. During those times I spent time in Siskiyou County's Emergency Operations Center getting real time information and attending fire management cooperator's meetings making sure we had the best information available to forward to our communities.

An 8 hour Community Preparedness Academy will be scheduled for February for Orleans and will be on a Saturday. Once we complete that I will be repeating the training for Happy Camp and Yreka throughout the Spring.

As you already know, water has and continues to be a big issue along the Klamath River. Emergency water filters were distributed along with emergency water delivered to Orleans and Happy Camp Tribal Elders and communities consistently for this entire year due to boil notices and shut downs. I will be exploring additional water projects with the State Water Resources Board to make sure we have clean drinking water on the river. One of our future projects worth mentioning is the water vending machines that will be installed at the senior nutrition program sites in Orleans and Happy Camp. This will provide additional filtered water to each of Winter 2024



## Karuk Tribe Water Quality

## Work Continues Post Copco 2 Dam Deconstruction

The Karuk Tribe Water Quality Program continues to monitor water quality in the main stem Klamath River and its tributaries. The program collects and assess things like water temperature, sediment, dissolved oxygen, pH, nutrients, as well as other parameters of interest. We are actively involved in the Klamath dam removal monitoring and responsible for monitoring water quality in 175 miles of the river (from Orleans, California to Keno, Oregon). This summer, Copco 2 (the smallest of the four dams being removed) was completely deconstructed and the river in that section permitted to run free for the first time since 1925. This dam had diverted the river completely, dewatering the

original channel which has now been restored. This coming year, Drawdown (releasing water) for the bigger reservoirs will begin on January 11 and dams will be removed when that process finishes in late spring to early summer. Drawdown will release sediments accumulated in the reservoirs, which are nontoxic and mostly consist of dead and decaying algae, but changes in water level will be small compared to tributary inputs downriver.

With dam removal underway, we are working hard to analyze and document the "dams in" condition of the river using data collected over the past 12 years. With this information we will be able to track the River's recovery. The

Tribe's commitment to long-term, place-based monitoring provides a unique opportunity for developing knowledge around river management and dam removal. We are also partnering with researchers at Stanford University and UC Berkeley to produce a social impact assessment of dam removal, studying the ways that dam removal impacts Tribal well-being, cultural resources, self-governance, education, and livelihoods.

Another new initiative is a pilot study with the Klamath Tribal Water Quality Consortium to evaluate the presence of a toxin of emerging concern, 6PPDquinone. This compound is derived from tire wear particles flushed from roads and is severely toxic to salmonids. This year the Tribe also petitioned the California State Waterboard to establish minimum instream flows for the Scott and Shasta Rivers, in the interest of providing adequate water to support salmon. We continue to work on collaborative projects involving fish disease, harmful algal blooms, and eDNA (Environmental DNA). We remain committed to our work protecting and understanding the Klamath River and its tributaries and the communities that live along them. 🗫

# Medical and Dental Facilities Construction Complete

The Karuk Tribal Health program is proud to announce the Grand Opening of our newly constructed medical and dental clinics will be held in January 2024. These two new beautiful buildings represent the tribe's resilience and our dedication to our membership, patients and community that we happily serve. These medical and dental clinics, combined with the existing Family Services facility, make up over 15,000 square feet of state-of-the-art buildings that will now serve our tribal membership and community members in Happy Camp.

The completion of the Medical and Dental clinics facilities marks the end of the phase 3 construction plan for the Happy Camp Health Campus and the beginning of Phase 4, which will include an additional 4,000 square foot Health Administration facility, that will house our Health Administration team, Community Health Representatives, Transporters and Medical Billing Department. This will be the final phase in our current Health construction plan in Happy Camp.

Our grand opening ceremony is currently scheduled for

later in January. More information will be posted on the Tribes website and everyone is encouraged to attend. There will be refreshments and a tour of the facilities. We're very excited for everyone to come out and celebrate the completion of these new facilities with us.





## **Cultural Burning Policy Update**

yukîi! It's been an exciting time in the world of cultural burning policy over the past couple years, so we wanted to give you an update on what the Karuk Tribe's Department of Natural Resources has been up to. Karuk people have stewarded our lands and waters since Time Immemorial, and have been using fire as a key way to do so. Karuk people have an aboriginal right to burn that has never been extinguished and have both a right and responsibility to steward our lands.

The issue is that this right has not always been acknowledged by those in positions of power, including federal and state agencies. This has resulted in overgrown forests that are both greater wildfire risks to our communities and also less abundant in the traditional foods, fibers, and medicines that we and our local wildlife depend on.

To address this issue head on, the Karuk Tribe released the Good Fire Report (version 1) in 2021, which outlined 12 key barriers to the expansion and scaling of beneficial fire (including prescribed fire and cultural burning) and also made recommendations for overcoming them. This version of Good Fire focused primarily on state-level policy, and has been widely cited by researchers, practitioners, and policymakers in the last couple years since its publication. In fact, it has been so influential, that it has led to a few new laws in California. These include Assembly Bill 642 (AB 642), Senate Bill 332 (SB 332), and Senate Bill 926 (SB 926), detailed below.

In September of 2021, AB 642 defined "cultural burning"

and "cultural fire practitioner" in state law; required the appointment of a cultural burning liaison to advise on matters of cultural burning at the state level; required the creation of a proposal for a prescribed fire training center; and established a state burn boss certification for prescribed burners; among other actions.

Following closely behind, SB 332 was signed into law on October 6, 2021, and changed certain liability standards for prescribed and cultural burning from simple negligence to gross negligence. If certain conditions are met, no person should be liable for any fire suppression or other recoverable costs if fire management agencies respond to help with suppression of an escaped burn. The conditions that must be met for a gross negligence standard to apply include the following: the purpose of the burn must be for wildland fire hazard reduction, ecological maintenance and restoration, cultural burning, silviculture, or agriculture; the burner must have landowner permission or approval of a Tribe to burn; and the burn must be conducted following applicable burn and air quality permit requirements; among others. For prescribed burns, SB 332 requires that the burner use a state certified burn boss to review their plans and conduct the burn according to their burn plan, while for cultural fire practitioners, no burn plan is required. While changing the gross negligence standard was a win, the state should still not expect cultural fire practitioners to get any permits to burn as

that is an affront to Tribal sovereignty, and so the Karuk Tribe has since sponsored Senate Bill 310, which is currently going through the legislative process (more on this below).

In 2022, SB 926 established the Prescribed Fire Claims Fund Pilot (Claims Fund) to support coverages due to losses from prescribed and cultural burning carried out by nonpublic entities such as cultural fire practitioners, private landowners, and non-governmental organizations. At present, the Claims Fund can provide up to \$2 million dollars per burn to cover losses. Burn plans are required to access the Claims Fund, however, and burn permits are required, if applicable.

Building off of these recent successes, there is still a key barrier to cultural fire practitioners from benefiting from SB 332 and SB 926 due to the fact that cultural burners should not need burn permits, air quality permits, or any other permit in order to carry out their unextinguished Tribal right to burn. Thus, with Karuk Tribe sponsorship, Senator Dodd introduced Senate Bill 310 (SB 310) in 2023 to authorize the California Natural Resources Agency and other agencies the ability to enter into sovereign-to-sovereign agreements with Tribes that explicitly acknowledge Tribal sovereign authority over cultural burning, and thus acknowledge that certain state permits do not apply. This bill is still in negotiations, and will likely be picked back up by the Assembly Appropriations Committee in early 2024.

While much has been happening on the state level, we have also been quite busy on the federal level. Last year, the Karuk Tribe's Director of Natural Resources and Environmental Policy, Bill Tripp, was appointed to be the Tribal government representative on the Biden Administration's Wildland Fire Mitigation and Management Commission, and continues to serve in that role. The Commission was created by the Bipartisan Infrastructure Law and charged with making recommendations to Congress to more effectively prevent, mitigate, suppress and manage wildland fires, including the rehabilitation of wildfire affected lands. This September, the Commission released their final report outlining

148 comprehensive, consensus-based recommendations to address the U.S. wildfire crisis, including over 20 recommendations specifically aimed to further enable cultural burning, Indigenous stewardship, and Tribal sovereignty, self-governance, and self-determination. This was a huge feat; however work remains to translate the Commission recommendations into legislative action and ultimately law.

To assist in this effort, the Karuk Tribe will soon be releasing an updated version of the Good Fire Report that will not only focus on state fire policy, but will include expanded sections on federal fire policy as well. The federal recommendations will build on, clarify, and delve into greater specificity about several of the key recommendations from the Biden Commission. Stay tuned for this report, expected in early 2024!

## I Need My Meds!

picture this: it is 3pm on a Thursday and you just opened your Metoprolol to discover you only have 3 pills left. What are you going to do?

Did you know there is a process for that? The Karuk Tribal Health Clinics process medication refills received from the pharmacy via electronic fax. We ask that you:

- 1. Call the pharmacy 7 days before you run out of your medication to request a refill
- 2. If you haven't received it 3 days before you run out call and speak to a nurse at the clinic
- 3. Come for your recommended appointments. At least once a year but usually every 3-6 months. Ideally medications are filled at this time, this eliminates the need for a request.

The clinics are held to specific standard in regards to medication refills. One of these is ensuring you are seen at regular intervals. Controlled substances require appointments at every refill! This is for your quality of care and to help keep you well.

What if it is after clinic operating hours? There is an on-call provider available 24/7. Call the clinic you usually visit and when prompted press one. There maybe a pause but the call service will connect you.



# Time for your flu shot.

There has never been a better time to get your flu shot! Let's talk about some common misinformation spread about the influenza vaccination:

### Myth: The flu shot makes me sick!

**Truth:** Unless you have had a serious reaction in the past the flu shot does not make you sick. It does not contain a live virus. It is more likely you were exposed to another virus like the cold after receiving your vaccination. To prevent this increase vitamin *C*, water, and rest 2 days prior and 2 days following vaccine administration.

## Myth: The flu shot now contains the COVID vaccine.

**Truth:** The vaccinations are separate. In our clinics they are even different manufacturers. Both injections have been FDA approved which means what's on the label has been tested and is what's in the syringe.

## Myth: Influenza is not serious so I don't need the vaccine

**Truth:** Each year roughly 650,000 people die from influenza due to breathing complications. Receiving the flu vaccine help protect you and those around you that may be at high risk.

Flu shots are available for all ages at all the tribal health clinics. Patients that have been seen in the last year are eligible to receive the vaccine without a provider visit.

## Karuk Tribe Human Services

yukii From The Director:

I am very proud to be a part of the Human Services team that cares for our Tribal Members. Embrace client care is our mission, but also our way of supporting and focusing on our Tribal members and community. The Human Services team has been truly the "guiding light" since my inception in May, 2023. From the behavioral health teams, Substance Use Disorder professionals, and front desk staff—you could not ask for a better team! Our department focuses on your well-being through therapy, addiction, and transitional housing. Our funding is backed by large grants to keep operations and training innovative and relevant.

Behavioral health needs have been exacerbated since the pandemic and additional barriers have emerged. Since then, there has been a whopping 21% increase in clients who are seeking mental health services and an even larger increase in medical management services. With small steps, the Karuk behavioral health team advises everyone to take action by focusing on self-care. Like your physical health, it is important to take care of your mental health. By doing so, self-care can increase your sleep time, heal your gut, lessen pain, and overall improve well-being.

### Take charge today by:

- Identifying times throughout your day to take breaks 1.
- 2. Take short walks after lunch/dinner
- Eating healthier 3.
- Pet your animals/engage in your hobbies
- Journaling or reading

Our behavioral staff are here for your mental health needs and are licensed providers who go through rigorous annual training to keep up with today's psychological issues to bring you towards kinder, wiser, and healthier well-being!

The Substance Use Disorder team is also here for all who seek sobriety, wellness, and support. Programs such as Substance Use Disorder, Relapse Prevention, group sessions, individual counseling, Batterers' Prevention, and DUI are enriched with culturally appropriate treatments to help overcome addiction. Our licensed, certified, and recovery staff are there every step of the way toward your sobriety and can be available in Happy Camp and Yreka locations.

#### **Opioid Crisis:**

The nation is currently experiencing an Opioid/Fentanyl crisis with these drugs pouring into the country through our southern border. The Karuk Tribe is not exempt from the effects of this crisis. Fentanyl is being added to street drugs in uncontrolled amounts that have resulted in many overdose deaths. Naloxone which comes in a spray bottle, can reverse the effects of Fentanyl, but that is after the

fact and not a solution. The first step in combating this crisis is for healthy family members to try not to enable addicted members, and to encourage them to seek treatment from the Karuk Substance Use Disorder Program. It can offer assessment, send them to detox or residential treatment, and offer relapse prevention services when they come back home. This step of not enabling family members is one of the hardest things that you will ever have to do, and I speak from personal experience. --- Joe Snapp, SUD Program Manager.

The SUD team is focused on strategic crisis initiatives to combat the opioid crisis and bring awareness to all three Karuk jurisdictions in Yreka, Happy Camp, and Orleans. All Karuk Tribe members, the community, and Karuk Staff are welcome to attend these FREE and informative trainings as they are all announced through Facebook, Karuk Tribal platforms, and to the community. The training includes an assortment of light food and fabulous prize raffles. This will be a great opportunity to learn about the drug that plagues our communities and has taken too many loved ones away. Be informed, be proactive, and be supportive---our Tribal and communities can promote harm reduction, prevent misuse, and understand the benefits of Narcan.

# IMPORTANT INFORMATION FOR YOU REGARDING REFERRALS FOR HEALTH CARE

### **PURCHASED REFERRED CARE**

Patients are RESPONSIBLE TO CONTACT PRC office to be eligible for Assistance from the PRC department with a referral.

- 1. If you were seen in the emergency room: Patients (their family or the care provider) must notify PRC of these services within 72 hours (three days of receipt of the services).
- 2. If you are an elder (65 years or older) or disabled, and seen in the emergency room or admitted to the hospital, Patients (their family or the care provider) have 30 days to call PRC.
- 3. Prior approval is required on all non-emergency services. (referrals)
  - a) If the outside provider refers you for additional services you must call the referral clerk at the clinic you were referred from for a second referral.
  - b) Co-pays or deductibles will not be paid without these referrals

Please notify PRC staff at 530-493-1659 OR 530-493-1600 ex 2156, 2151 or 2155 of all appointments.



# Low Income Assistance Programs (LIAP)


- Safety Net Services- This program helps low income families with food, shelter, and clothing. The applicant must reside in the service area, be a Karuk tribal member, descendant or member of any federally recognized tribe, and a low-income household.
- Low Income Heating Energy Assistance Program (LIHEAP)- This program provides energy assistance to eligible tribal households with electricity, propane, firewood, and minimal weatherization. The applicant must reside in the service area.
- General Assistance- This program provides low income families with food and/or clothing, shelter, burial and emergency assistance. Benefits will be adjusted depending on income received.
- Adult Care Services- Adult care assistance provides non-medical care for eligible elders. Background checks are required.
- If you've experienced a loss in income due or hardship due to COVID-19, you may be eligible for additional assistance. Contact the LIAP Department for more information.

For those residing outside of our service area there may be other resources available. We encourage you to reach out to

your local Community Center or Resource Center, these centers may have additional resources for accessing energy assistance and/or food vouchers. Northern California Indian Development Council (NCIDC) is another great resource and has offices located in both Yreka, CA and Eureka, CA.
