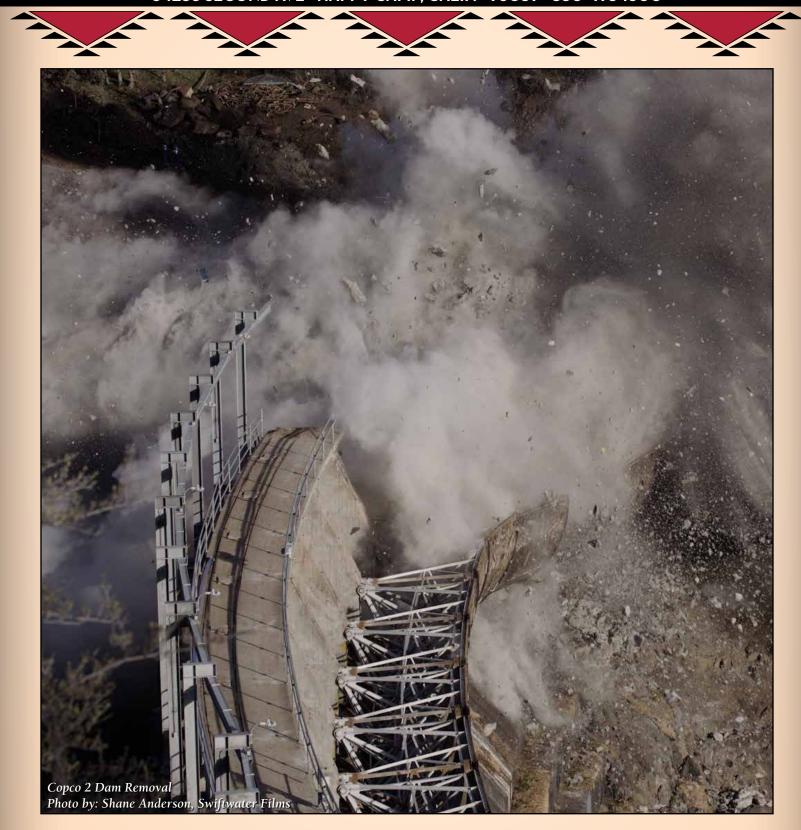

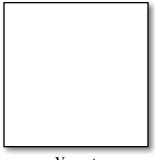

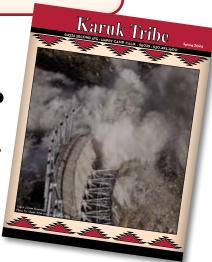

Notes From The Chairman

yukii, koovura,

I hope all is well with Tribal Members and Descendants. What is Tribal sovereignty and how is it important to the Karuk Tribe? At its core, Tribal sovereignty is the inherent right of Indian Tribes to manage their lands and activities on those lands. Tribal sovereignty is also the political status of Indian Tribes as governments. The Karuk Tribe Council has had to fight to get other government entities to recognize that we are sovereign and we know best how to make decisions that impact our Tribal People and communities.

Tribal sovereignty is not a new concept. Indian Tribes governed their lands long before contact from other nations. When the Europeans arrived, they acknowledged Tribal sovereignty when they entered into treaties with Native Nations to secure peace and build trade relationships. Upon its formation, the United States likewise recognized the governmental status of Indian Tribes and engaged in several hundred treaties for the same purposes. The U. S. Constitution acknowledges Tribal sovereignty in several provisions.

This early respect for Tribal sovereignty was sadly followed by a series of misguided federal policies that forced the removal of Tribal governments from their homelands, resulting in dozens of trails of tears. The next policies fostered the taking of Indian lands and stealing Native children from their families-where they were forced into federal boarding schools and forbidden from speaking their language or practicing their religion.

However, our ancestors persevered. They fought and many made the ultimate sacrifice to protect our sovereignty and our way of life. This, as then President Richard Nixon proclaimed, is a "record of endurance, of survival, adaptation and creativity in the face of overwhelming obstacles". Then on July 8th 1970 President Nixon did away with all those failed policies and renewed the respect for Tribal sovereignty by ushering in the current federal policy of supporting Tribal governments self-determination.

So, what does this mean for the Karuk Tribe? It means that we now have the opportunity to manage our own lands, starting with Co-management. Co-management means that we are willing to work with our federal partners but we must be able to take the lead in the management process.

Since time immemorial the indigenous people living along the Klamath River managed their forests and waterways with cultural burning and Tribal Ecological Knowledge (TEK) that was passed down from generation to generation. More than 100 years ago those management practices were outlawed by the federal government without consulting with the people who lived there. The federal government now realizes this was a big mistake. They are coming to Indian Country and listening to Tribes tell their stories about how they were able to avoid the devastating fires we have today. Stories about how to manage our forests that will enhance our creeks and streams not destroy them. Stories about how our Elders observed the ways Mother Nature took care of these lands and passed that knowledge to the next generation.

Where do we go from here? Now that we have their attention, we do not ask but we demand that the federal government live up to their trust obligations and make sure that whenever there is a project needed in Indian Country, Tribes not only have a front row seat at the table, but there is consensus on how to move forward after the meeting is over and that the Tribes receive equal funding. Funding so we can implement Tribal Ecological Knowledge, funding that is equal to United States Forest Service or the Department of Fish and Wildlife. Then, and only then, will we be able to manage our forests and waterways in a way that protects and preserves these resources for our next generations.

I recently attended the Tribal/Department of Interior Budget meetings in Washington D. C., I listened to our federal partners tell Indian Country that they did not have the funding to fulfill their trust obligations to Indian Country. I reminded them of the fact that Indian Country receives 1/10th of 1% of the funds that go to foreign countries, and that this is unacceptable because foreign countries cannot make America a stronger nation but Native Nations can. yukii I continue to learn the programs, the policies and procedures in the Housing Authority the Gaming Authority, the Enrollment and the Health Department. I also sit on a few different committees.

The Housing Authority by itself is a huge program and I am very happy to be involved with this program. I have been on multiple training opportunities with housing and I am very happy to report that our Housing Authority compared to other Housing Authorities is doing very well. I know that we have a very large waiting list and we will continue to work together to alleviate housing shortages and battle homelessness. The Karuk Tribes housing authority staff is doing a great job and we all should be respectful of their efforts.

Also, our Department of Natural Resources is really leading the way in their fields. The Fish and Fire Departments have been the frontline in restoration efforts on the Klamath

River. We continue to strive for traditional ecological knowledge (TEK) to be implemented and recognized as a valuable resource for the health of our communities.

Folks can go online and look up the great work the Department of Natural Resources has been doing, including Dam removal and the good fire reports. We should be very proud of our Department of Natural Resources.

I got to meet with the Congressman and the Governor. We discussed co-management, restoration efforts and how we need to get back to logging, not clearcutting, but changing the name of logging to restoration for removal of forests fuels is restoration at this point. We really need to think about how we can preserve our forests because currently the forest management just lets the forests burn down. They get big money to let it burn and we have to put a stop to that or our future generations will not see conifer forests.

I will continue to fight for our rights as Karuk people to manage our lands the way Creator intended us to.

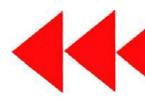

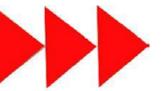

<u>NOTICE IS HEREBY GIVEN</u>: that on <u>Tuesday, November 5, 2024</u> the Karuk Tribe will conduct a General Election. Candidate packets will be available at Tribal Administrative offices in Happy Camp (Admin), Yreka (KTHA Office), and Orleans (DNR) on <u>Wednesday, May 15, 2024.</u>

Polling places will be open from 7 AM to 7 PM at the following locations:

If you are already an absentee voter, it is your responsibility to make sure your address is up to date with the Enrollment Office to ensure you receive an absentee ballot.

As Director of Public Works, for a little over a year I can honestly say this management crew has been productive and hard working in all three communities. Behind the scenes, not often talked about, are multimillion-dollar projects that require miles of foot work and as always, a ton of paperwork. A project that the Karuk Department of Transportation Director and I have been working aggressively on is the Ishkeesh Bridge build in Happy Camp. At first the possibility seemed impossible, until the Tribal Liaison from the Army Corps of Engineers, came to Happy Camp and heard our request for support. In February 2024, we submitted a \$11 million dollar grant for the studies and design. If this opportunity comes to fruition accessibility and advancements in Food Sovereignty, Housing, Economic Development, Cultural and Traditional uses of our land will become a reality.

It has been quite intriguing to learn about the Karuk Tribe Lands and the plans for the future of those lands. One of the main objectives of the Karuk Tribe Lands department is to put Tribal parcels into Tribal Trust. Tribal trust land establishes the Karuk Tribe jurisdiction and broadens Tribal Sovereignty. The Karuk Tribe has worked diligently over the past 30 years to acquire and place lands into Trust for the Karuk Tribe.

The Lands Management Department has been working on yearly water rights reports for all Karuk Tribal properties. There have been ongoing land applications that continue to go thru the process from fee to trust. I have recently completed training in Geographic Information System. This Spring 2024

type of software is great to learn in order to understand geospatial information. I am also currently working on obtaining my Real Estate license.

I have been placed with the task of developing and creating a Karuk Tribe Workforce Policy. As the Tribe continues to grow and operate the need for housing becomes evident. The Karuk Tribe Workforce Policy will help ensure that housing needs are being met for new and current employees.



I am enjoying this new position and look forward to helping maintain the Karuk Tribe Lands.

News from Karuk Tribe Emergency Manager

aruk Emergency Management is here to serve and protect life and property, through education and training in preparedness, response, mitigation, and recovery (All Hazards Approach). It has been a busy first year for your Emergency manager, Darrell Frost who came to the Karuk Tribe from a diverse background in local Fire Service, Law Enforcement, Emergency Medical Services, and Emergency Management. He has been busy with several projects including an Emergency Water Grant that is providing clean drinking water to the communities of Orleans and Happy Camp, CPR and First Aid training to Staff, our tribal communities, and Fire service.

We had our first Community Disaster Preparedness Academy in Orleans on February 3rd with well received success. Last Summer, the Emergency Services Department was extremely busy during the last Fire Season doing Emergency Evacuations in Scott Bar and Hamburg, delivering emergency medications through road blocks for our Clinics, and providing direct services to Tribal communities, including Generators, Fuel, and real time weather updates. The holiday season included some fun activities, like the Shop with a Cop Program. We were able to assist with providing transportation to the event in Yreka and back home to Orleans for area youth along with Tribal housing. Darrel Frost is honored to serve the Karuk People and communities as our Karuk Tribe Emergency Manager.

yukii from the Karuk Department of Transportation! We've been super busy working on multiple projects and plans. Here's a list of just a few of them. We're also going to be working on our Long Range Transportation Plan update. Please join the community meetings to provide your valuable input when the dates and times are announced.

Orleans/Somes Bar Projects

Call Box installations – Humboldt County Association of Governments Technical Advisory Committee, at KDOT's request, initiated and paid for a project to install eleven

Emergency Call Boxes along SR96 from Willow Creek to Somes Bar; six of which are between Bluff Creek and Somes Bar. These call boxes will allow for calls for help to be placed in times of emergency, and/or if someone's vehicle breaks down in a location where there's no cell service.

Orleans Beautification Project (Clean California) -

KDOT has been working with Caltrans District 1 staff on implementing a Clean California project for Orleans. The project elements include dual language welcome signs (Orleans/Panamnik), 10 lights with changeable decorative banners, and an enhanced crosswalk with a tribal pattern. These project elements were chosen by the community of Orleans via survey and at a well-attended meeting last fall. Project completion date is expected by the end of March 2024.

Orleans Bicycle and Pedestrian Path – this project is still in the early planning stages. We recently held an Open House meeting, which many community members of all ages attended. This project would potentially provide a multi-use path through Orleans, from Camp Creek to Pearch Creek. Unfortunately, we have had at least five traffic related fatalities within the project area over the years. Our plan with this project is to slow traffic through town with additional lighting, a path on one side of the highway for kids and adults to safely walk and bike, as well as other traffic calming measures.

Somes Bar Capital Maintenance Project (CAPM) – Karuk DOT has been collaborating with Caltrans District 2 on a project from postmile 0.0 to 12.0 in Siskiyou County (Somes Bar). This project will include improved drainage, installation of guardrails, signage, striping and paving. There is also planning in the works for a future project to make additional safety improvements the entire length of SR96. When you notice places along this route that need guardrail, or other safety enhancements, please shoot me an email with a postmile number so I can report it to Caltrans.

Happy Camp Projects

Happy Camp Parking Expansion Project – Karuk DOT anticipates the paving and striping for the new medical and dental centers in Happy Camp to be completed by mid-June when warmer weather and asphalt plants start back up again. In the meantime, compaction and ADA parking standards were met, and the buildings are absolutely beautiful!



Open House Happy Camp Complete Streets

Happy Camp Complete Streets Project – After the Tribe was awarded \$9.9 million dollars in Active Transportation Program funding, there were several community meetings

held in October of 2022 and September of 2023, with great attendance from community members, tribal staff, California State Representatives (Megan Dahle & staff), Siskiyou County transportation representatives and business owners from within the project limits. Interactive maps were displayed for people to mark-up with their comments, concerns and suggestions. Caltrans District 2 took the information gathered and are incorporating as many of the changes as are feasible. Construction is scheduled to

begin in summer of 2024/2025. Sending out a special Yootva to Partner's Deli for providing a delicious meal for those who attended the last open house meeting.

RAISE Grant application – After months of preparation and hours of staff time compiling information, meeting with internal and external stakeholders and grant writers, Karuk DOT and the Karuk PWD submitted a proposal to the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Discretionary Grant Program for the planning of a bridge outside of Happy Camp, which would stretch across the Klamath River from State Route 96 to "the Ishkeesh Ranch". The Tribe plans to develop the property in the future and this bridge would be instrumental in allowing that to happen in a more achievable manner.

Yreka Projects

Yreka Roads Safety Project – KDOT applied for, and was awarded \$673K in grant funding from the US Department of Transportation Federal Highway Administration Tribal Transportation Program Safety Fund for a safety project, which includes elements such as additional permanent speed bumps, signage, guardrail, utility relocation, and curbing. There have been at least three or more crashes along Apsuun Road, two of which tragically resulted in fatalities. This project aims to slow traffic and create safer routes of travel within tribal housing. We also plan to build trails and walking paths in the area as a future phase of the project.

Yreka KDOT Shop & offices – In 2023, the Tribe purchased a small piece of property off of Oberlin Road for the Department of Transportation. After years of not having a place of our own in Yreka, we now have a shop and offices for our KDOT staff. We are so excited, and would like to thank tribal council for making this happen.

Other Projects & Road Maintenance

Transit Project – Karuk DOT was recently awarded two highly-competitive grants to develop a transit program. We will be conducting a feasibility study, hiring a transit coordinator, and eventually purchasing a van, and hiring a driver to facilitate transit services between Orleans and Happy Camp, and beyond.

Road Maintenance – Whether it be weed-whacking, clearing drain inlets, cleaning sidewalks, crack-sealing, re-painting parking areas, fixing potholes and broken curbs, maintaining equipment, or replacing signage; the crew is always busy. Karuk Tribe Hillside Medical Complex Nears Final Phase

n December 2023, the Happy Camp Community received state of the art Medical and Dental facilities. The Karuk Tribe has been working towards this goal for more than two decades, to serve the community and membership with the best environment possible to receive health care. The facilities that were constructed give each department room for growth. The new Medical Clinic will soon have the capability of offering medical x-rays to the community of Happy Camp, something that hasn't been done for about 25 years. The community of Happy Camp has shown that they greatly appreciate the new facilities.

In summer of 2024 the Karuk Tribe will start the construction of the New Medical Administration building located on Hillside Road. This facility will be the final construction in the build out of the new Health Care Complex in Happy Camp. The new facility will allow for all of the medical administration employees to be housed in the same building, on the same compound as the rest of the medical facilities. this will make everything easier for the membership and community members to be able to access all of their medical needs in one location.

Aan Chúuphan to Build Fiber-**Optic Internet Access in Panamnik**

n 2015 the Karuk Tribe launched an Internet Service Provider (ISP) in Orleans. Áan Chúuphan, which translates from Karuk to English as Talking Line, has been providing unlimited broadband to homes and businesses in the Panamnik (aka Orleans) community using wireless (Wi-Fi) technology. Residents currently only have the choice of Aan Chúuphan or satellite Internet access. Unlike satellite service, Áan Chúuphan Internet access has no data cap, meaning that subscribers can utilize the service non-stop without metered access and with no overage fees. Sadly, the bandwidth that Áan Chúuphan can offer over wireless technologies is not meeting the new high-speed broadband needs of the community, especially after the rise of video conferencing during the Covid-19 pandemic.

To address this need, the Karuk Tribe is planning two expansions to the Áan Chúuphan service. The first expansion is a project call the Klamath River Rural Broadband Initiative (KRRBI). This project will build fiber optic cable from Orleans all the way to McKinleyville, and to tie into neighboring broadband providers along the way. This project will provide redundancy to the entire community, and will allow for lower bandwidth costs, since Áan Chúuphan will be able to select the most cost-effective upstream bandwidth provider. The

Karuk Tribe may also be able to add additional customers in areas that are currently unserved with high-speed broadband.

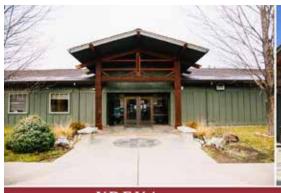
The second expansion is to build Fiber-To-The-Home (FTTH) in Orleans, where an underground fiber-optic cable will be installed to every home and business in the great Orleans community. This project is currently in the planning stages, with a grant received in 2023 from the National Telecommunications and Information Administration Tribal Broadband Connectivity Program. This grant will aid the Karuk Tribe to plan for FTTH, including environmental studies and engineering plans. The Karuk Tribe has applied for over \$25 million in funding to build this project, and is waiting to hear back from the grant agencies whether this funding will be approved.

In addition to home internet access, the Orleans Computer Center and Panamnik Library offers computers for use by the public at no cost. Please stop by the center to check your e-mail or look into getting a GED or college degree online. The Computer Center is located at 459 Asip Rd.

Grant Work and Projects Underway

Orleans, Happy Camp, and Yreka

Work is wrapping up on the Department of Energy (DOE) Grant to add solar panels and battery backups to 39 Elder units in all three communities as well as the Wellness Center in Happy Camp. Work began in May starting with Orleans first, due to their unreliable electric service. These systems will provide uninterrupted, clean energy, via batteries, to serve the needs of Elder tenants during outages. At this time, all solar panels, batteries, and inverters have been mounted and installed. The systems will be fully activated and started as full clearance is received from the utility providers.

Orleans

HUD Indian Housing Block Grant (IHBG) Competitive Grant funds are being used to construct eight (8) two-bedroom, single family units on the property previously known as the Pines RV Park. Demolition has been completed at the site and construction permits were finally issued! The next step will be advertising for the infrastructure, followed by construction of the homes. This project had a very slow start due to Humboldt County permitting requirements, but it is very exciting to finally be ready to start construction.

Federal Emergency Management Agency (FEMA) funding is being used to replace all wood fencing throughout the Orleans community with powder coated chain link and privacy slats, to mitigate fire risk. This work began March 18 and will continue until complete.

Happy Camp:

American Rescue Plan (ARP) IHBG fundin is being used to construct seven (7) two-bedroom single family units in the Happy Camp community along Second Avenue. The Force account crew has been braving the rain, sleet, and snow to continue making steady progress on the framing, sheathing, and trusses for these homes to get them dried in. *Keep an eye out for an article highlighting KTHA's Force Account Crew in the upcoming Summer Edition*.

FEMA is funding a grant to install four (4) generators at multiple locations throughout Happy Camp, to ensure continuity of services. Unfortunately, there is a long lead time on production of the generators, so progress has been slow on this project.

Yreka:

Work continues on the California Office of Emergency Services (Cal OES) grant to retrofit the exteriors of the Yreka units to mitigate wildfire danger. The project is being done in phases over several years from multiple funding sources to accomplish all of the tasks. This first phase includes siding/painting/decks on the apartments, siding on the 30 homes, and painting/decks for the Elder units. The second phase will be funded by FEMA BRIC and Cal OES and includes: metal roofing and fence replacement for the apartments/30 homes/

elder units, and the updated decks for the 30 homes. The defensible space and fuels reduction work has already been completed and looks fantastic!

KTHA also continues renovating all 63 Yreka apartments which are now over 30 years old! The kitchens, bathrooms, and flooring are all being replaced along with other nonroutine repairs such as LED light upgrades and replacing exterior security lights and faucets. Although it is frustrating to see so many vacant apartments, we ask everyone to understand that those units are not move-in ready, they have been fully stripped to complete the work. Once the first batch is complete, the complex process of transferring existing tenants into their newly renovated apartments will begin, and continue until all units are renovated. This pairs nicely with the exterior retrofitting being done to the units. The dumpster gates were recently replaced, and look much better now. After the exterior work is complete, all of the apartments will be landscaped with eco-friendly synthetic lawns to finish off this long project, which will greatly improve the curb appeal of the Yreka apartments.

Programs and Applications

The Karuk Tribe Housing Authority offers Low Income and Elder Rental Units in Yreka, Happy Camp, and Orleans to income eligible Tribal individuals and families. KTHA also offers the following assistance to income eligible Karuk Tribal Members: First-Time Homebuyer Loans, Down Payment Assistance Grants, Mortgage Relief Grants, Student Rent Vouchers, Elder Rent Vouchers, and Temporary Rent Vouchers, Home Replacement Grants, Home Rehabilitation & Weatherization Grants and Loans, and Home Improvement Loans.

Samantha White, Admissions/Loan Specialist, receives and processes all applications for KTHA assistance. We encourage Tribal Members who have any unmet housing needs to SUBMIT AN APPLICATION! The income limits that determine eligibility are not as low as you may think; many working families are still at or below 80% of US Median Family Income Limits set by HUD. Please be patient as you go through the application process and understand that everyone's experience will be unique. There is a checklist on the application listing mandatory items that must be included for all applications, including all of them at the time of application makes the process much faster. Additional documents may be requested depending on your individual circumstances while processing the application. All applicants will be notified if there is missing documentation, or if additional information is needed, in order to continue processing the application, as well as when the application is deemed complete. Processing times are different depending on the program applied for due to the necessary documentation, research, and third-party verifications required for each individual program.

Life Insurance Increase - Effective this plan year, the face value of the Karuk Tribe's Employee Life and ADD Insurance was raised from \$15k to \$25k. There's NO change required by employees as the increased amount is seamless in design. However, HR and Payroll recommends that each employee should review their beneficiary designations and make sure they are up to date and per their wishes.

This change was implemented to acknowledge the significant costs that families and beneficiaries face when they suffer the loss of a loved one and it also puts us in a stronger competitive position among our peers. The Karuk Tribal Council believes this is one of the many ways they are able to express how much each employee means to them and is a gesture of care and compassion for those left behind.

Karuk Family Leave - As announced earlier, the Karuk Tribal Council approved their Karuk Family Leave, unlike the Family Medical Leave, Karuk Family Leave (KFL) was created for those employees who have completed their initiation period but not yet attained a full year of employment. KFL provides qualified applicants with up to 8 weeks of KFL for qualifying events such as their own serious health needs, care of family members (as defined), the birth, adoption or fostering of a child(ren). 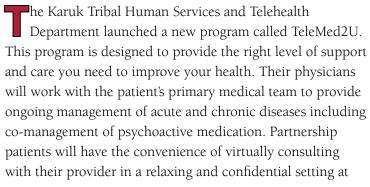

Karuk Education Department's Youth Cultural Practitioner Program

In collaboration with Cultural Practitioners, Jackson Street School, and Karuk Education, students of Jackson Street School were given the opportunity to learn about the Karuk Cultural tradition, the Brush Dance. The Brush Dance is a Karuk Traditional dance and ceremony where participants gather to sing, dance, and heal a sick child. Students from grades 4th through 8th learned songs, lining up, and demonstrative regalia, including the significance of dentalium, abalone, basket hats, quivers, and also learned how to introduce themselves in Karuk.

All students also had the chance to make a triple stranded necklace to take home with them at the end of the program. The Karuk Brush Dance class also marked the onset of the Karuk Education Department's Youth Cultural Practitioner (YCP) program, established to create opportunities for teen youth to participate in learning and teaching Karuk culture to the younger generation. The YCPs are learning how to work with the younger generation while also learning more about their culture and working towards life goals.

Throughout the program, Cultural Practitioners provided instruction and support to the YCPs during the Karuk Brush Dance Class. The students and cultural practitioners worked for 3 consecutive weeks to prepare for a presentation to their school during each grade's awards assemblies to show their families, school staff, and peers what they learned.

The YCPs assisted the Cultural Practitioners by demonstrating lining up, jumping center, and learned two songs. One song was introduced by Franklin Thom, and the other by student Harlee Moore. Harlee Moore presented her song to the class, which became a highlight of their presentation during the awards assembly. The Brush Dance class was the first of its kind to be conducted at Jackson Street School, marking a monumental milestone for integrating Karuk Culture into the school.

This Brush Dance Class, like many more to come, has opened the door for establishing Karuk cultural identity, acceptance, revitalization, and introduction to Karuk culture for non-native youth. The Karuk Education Department is determined to establish Karuk culture as an equal in the classrooms across the Karuk territory and service areas, normalizing Karuk practices.

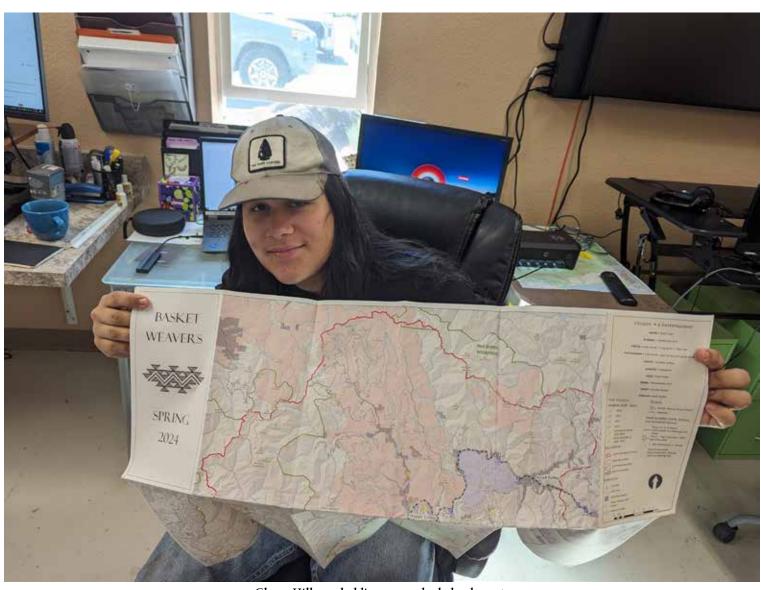
GIS Division within Collaborative Stewardship Program

Some GIS Terms to Know:

GIS - Geographic Information Systems

What is GIS? This is probably the most asked question posed to those in the GIS field and is probably the hardest to answer simply. GIS is a technological field that incorporates geographical features with tabular data (otherwise known as attribute data) in order to map, analyze, and assess real-world problems.

GPS - Global Positioning Systems

Method for identifying locations on earth using triangulation calculations of satellite positions. The Global Positioning System (GPS) is more than a handheld device that tells you where you are. The entire system is the receiver device, a number of ground stations, and the network of Earth-orbiting satellites.

Geospatial data

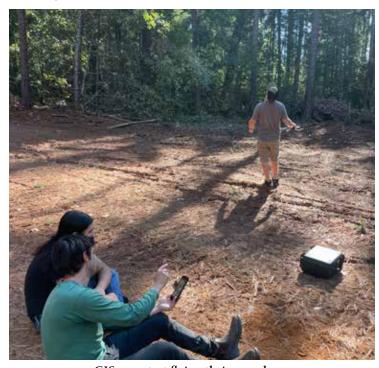
The word geospatial is used to indicate that data that has a geographic component to it. This means that the records in a dataset have locational information tied to them such as geographic data in the form of coordinates, address, city, or ZIP code.

Aerial imagery or photograph

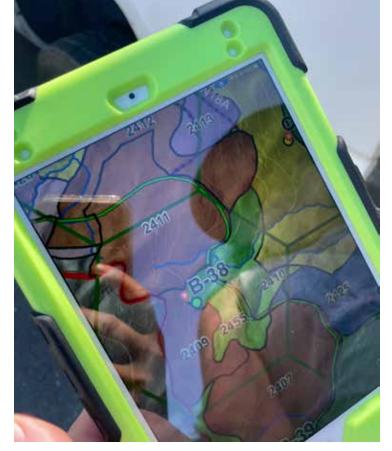
A photograph of the earth's surface taken from an aircraft, satellite, or other remote platform. Aerial photography is often used as a cartographic data source for basemaps, to locate geographic features, and to interpret environmental conditions.

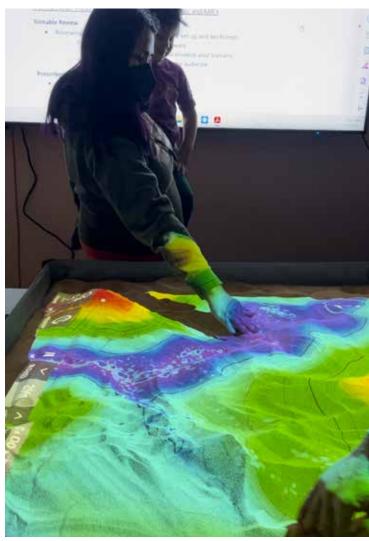
Simtable is a company that provides digital sand tables and custom simulation models to the wildland fire, emergency management, and educational communities.

Fish are doing well in the Klamath River

t has been about 6 weeks since drawdown of the reservoirs on the Klamath River in preparation for removal of J.C. Boyle, Copco 1, and Iron Gate Dams. A lot has happened to the River downstream during the days and weeks since the drawdown was initiated. As 100 years worth of sediment and dead algae held back by the dams was released, decomposition of these sediments used up the available oxygen in the water, leading to low dissolved oxygen levels in the river downstream of Iron Gate Dam. This low oxygen persisted for approximately 24 hours killing many fish and invertebrates in the reach immediately downstream of Iron Gate Dam.

Water quality conditions improved downstream as tributaries diluted the muddy and low oxygen water. Despite this, the effects of this low dissolved oxygen resulted in a fish die-off event that was evident as far downstream as Seiad Valley. It was not a fun day to be a fish biologist when I was washing mud off of dead juvenile salmonids in order to identify them. Any large scale fish die-off can be tragic and difficult to witness, but this event was anticipated and planned to do the least harm possible while still allowing for the fastest removal of the dams.

Drawdown was initiated in Mid-January to have the least impact on wild salmonids in the Klamath River. Chinook Salmon and Coho Salmon have typically completed their spawning activities by January and most Coho Salmon spawning occurs in tributaries outside out of the mainstem Klamath River. Juvenile fish occupancy in the river is also lower in January than in any other month of the year, minimizing risk to juvenile salmonids.

It is known that some Coho Salmon juveniles use the Klamath River as winter habitat, so an effort was undertaken in the month of December by the Karuk Tribe in collaboration with RES to capture as many of these fish as possible and move them to off-channel habitats that would be unaffected by water quality conditions in the main river. Approximately 500 Coho salmon juveniles were captured and moved during this effort.

It is impossible to know how many juvenile Coho Salmon may have been affected by drawdown, but investigations enumerating mortalities in the most impacted reaches did not observe any dead Coho juveniles. As fish surveys ramp up for the season, we are out capturing fish in the mainstem

river including in the zone where water quality was the worst. As of the first week of March, healthy Chinook Salmon fry have been captured by seining in locations downstream of the mouth of the Shasta River.

Routine seasonal monitoring of juvenile salmon outmigration in Spring is done using traps deployed by U.S. Fish and Wildlife Service in collaboration with the Karuk Tribe. This year's effort has begun, and fish captured the first week of March in the reach upstream of the Scott River look healthy.

We expect turbidity (a measure of water clarity) levels to be higher than we are accustomed to as the newly uncovered river stabilizes in the old reservoir footprints. While there is uncertainty in how soon water clarity gets to a level we would find aesthetically pleasing, turbidity levels are already stabilizing at levels that are acceptable to fish survival and are only expected to improve as time goes on.

One can't expect to fix a one hundred year old problem without some risk or uncertainty. So far, the effort to remove dams in the Klamath River is proceeding as expected. Water quality measurements of dissolved oxygen levels have improved and turbidity levels are improving faster than many expected. It appears the plan to initiate drawdown at a time to minimize risk to Salmon and Steelhead was successful and I am looking forward to the Juvenile salmon currently migrating out of the Klamath being able to return to an unblocked river.

Karuk Department of Natural Resources Plans for Expansion

he Karuk Department of Natural Resources' (KDNR) office is located in Orleans, California but services all of the Karuk Aboriginal Territory. This Department has grown from 2 employees and a budget of \$150,000 in 1989 when it began as a Fisheries Program, to 85 employees (and growing) across 10 program areas with an annual operating budget of at least \$10 million. We are in an excellent situation for growth and expansion, but currently held back by our small facility and limited office spaces. Thanks to funding from the Department of Conservation, the Bureau of Indian Affairs, and an anonymous donor, the Karuk DNR is planning an expansion project to serve the needs of our natural/cultural resources and our people and communities. Going off of preliminary plans drawn up in 2015 (pictured), we will be updating and expanding these to meet current and foreseen growth.

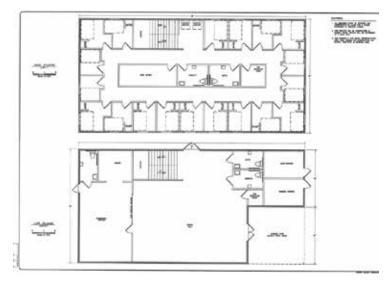
One building in the works is Taayvávan Iptáamax (many people stoke the fire), a climate resilience/prescribed fire training center. As we know, fire has been a part of our landscape since time immemorial and the removal of it and our cultural burning practices are what has led to the fuel heavy forests that surround our communities today and create high-risk of severe fire effects. This center is planned to be an evacuation center, clean air center, training center, and a place for gathering to learn, prepare, and build community resilience.

The Karuk Tribe is a leader in the realm of cultural and prescribed fire and our training exchanges (TREX) have brought fire practitioners from around the world to learn. We are also on the forefront of policy change and lawmaking around cultural burning practices and bringing those decisions back into the hands of Tribal people. Having Taayvávan Iptáamax will help us build up our TREX programs and also train more Karuk people to steward our lands safely.

Taayvávan Iptáamax was the starting idea for DNR expansion, but with such a facility we need all of the other infrastructure to support it. We need office spaces for our ten programs, storage and processing space for traditional foods, fibers, and medicines to share with the community, places to host intergenerational learning gatherings, labs and equipment bays, IT support, and also housing for the staff it takes to build up these functions. All of these things are being supported by the funding previously mentioned, along with land purchases that will make these things possible.

We expect to have the engineering and design completed by Summer 2025 for an add on to the current DNR building, Taayvávan Iptáamax, and at least two other buildings, possibly more. Construction will come after that with the securing of the next step in funding for this project. We will be designing some of these facilities with the intention that in the future, they can be replicated in other areas in Karuk Territory to align with our plans to expand.

Air Quality Sensing

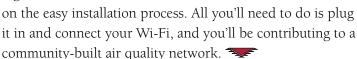

Do you have breathing problems? Would you like to prepare for wildfire season? Karuk Department of Natural Resources in collaboration with the Blue Lake Rancheria and the Schatz Energy Research Center at Cal Poly Humboldt is working on a project to improve air quality monitoring in the area. Our goal is to provide community members and organizations with free PurpleAir monitors that can be used to monitor indoor and outdoor air quality. With these PurpleAir monitors, you can see real-time air quality conditions. This allows individuals and families to see the smoke or particulate exposure in their environments and make decisions regarding when to seek shelter, and when it may be safer to stay indoors and avoid smoke.

Hosting a sensor means that you can see the air quality in your home or outdoor local environment in real-time. The sensor is small and easy to install but it needs two things: a Wi-Fi connection and a power outlet. The Wi-Fi connection

allows the sensor to send the data to the network, so you can see it on a map. You can also scan the QR code below to access the Purple Air map. The power outlet provides electricity to the sensor, which uses very little energy (about \$2 per year).

Low Income Assistance Programs (LIAP)

Below are the Low Income Assistance Programs (LIAP) offered by the Karuk Tribe. Please note that all programs have income requirements that must be met before providing services and LIAP has 30 days to process complete applications.

- Safety Net Services (CSD) This program helps low income families with food, shelter, and clothing. The applicant must be a Karuk Tribal Member or Descendant. The maximum amount of assistance provided is up to \$500.
- Low Income Heating Energy Assistance Program (LIHEAP) This program provides energy assistance to eligible tribal households with electricity, propane, wood, and minimal weatherization. The maximum amount of assistance provided is up to \$500.
- General Assistance (GA) This program provides low income families with food and/or clothing, shelter, burial and emergency assistance. This program is for Karuk Tribal Members and Members of Federally recognized Tribes only. The maximum amount of assistance for food, shelter, and clothing requests is up to \$500.
- Adult Care Services Adult care assistance provides
 payment to caregivers for non-medical care for eligible
 elders. Background checks for providers are required
 and a home assessment will be completed to determine
 eligibility.

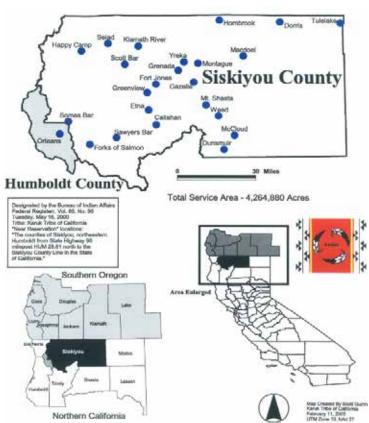
As a general reminder: assistance will be offered on a first come, first served basis until program funding is depleted. Qualifying low income households applying for LIHEAP, CSD, and GA will be awarded a maximum amount of up to \$500 in assistance. To receive assistance for rent and utilities, you must have a balance due to receive services. Credit will no longer be applied to accounts with a current zero balance.

Pi-nay-a-fitch and the Star Maidens (A Klamath Legend) By Ramona Grant, '37

One day Pi-naya-fitch and his son went hunting. It was very stormy and the ground was covered with snow. They went a long way, and, after two days of wandering, they found their way home, when they were but a short distance from home, Pi-naya-fitch sent his son home and then he went



back the way they had come.

He looked up into the sky and saw the Star Maidens dancing. They seemed to be having a good time, so Pinay-a-fitch wished that he could go up in the sky and dance with them. Suddenly he found himself in the sky, watching the Star Maidens dance. He begged them to let him dance with them, but they wouldn't let him. They told him that, if he once started dancing, he couldn't stop. But Pi-nay-a-fitch begged until they let him dance with them. They danced and danced day and night. Finally Pi-nay-a-fitch got thirsty. He asked the Star Maidens if he could stop and get a drink, but they wouldn't let him. Later he got very hungry. He begged the Star Maidens to stop, but again they refused. Finally Pi-nay-a-fitch got so tired that one of his legs came off and dropped through space. Then his other leg came off, but still he had to keep on dancing. Then his arms became tired of holding his partner, so they dropped off too. He still had to slide around with his body. Soon his head too dropped off, and finally his body dropped through space. All his bones had fallen in a heap at the bottom of a high cliff. One day an Indian maiden and her father were walking along at the bottom of this cliff when they came to a pile of bones. Not thinking anything, the girl stepped over the bones and then Pi-nay-a-fitch came back to life.
