Proposal Deadline: Thursday, February 26th, 2026, no later than 4:00 p.m. (PST)

The Karuk Tribe requests proposals for the following Scope of Work required for the installation of an emergency power generator for our Family Services Center located at 64105 Hillside Road. Happy Camp, Ca. 96039. A new 125kw propane emergency generator unit. Your bid will include the following items: New propane-fueled 125 kW generator w/lockable enclosure, appropriately sized fuel tank/tanks, and all necessary plumbing, block heater, battery, flexible connector, standard controls, auto-switching gear, all freight to jobsite, full installation (including gas lines and wiring), and start-up (load test, fuel adjustments). We also require a walk-through of the basic operation of the unit with Tribal employees and a successful function test in a simulated power outage. All **Federal, State, and Local** codes must be strictly followed. All applicable inspections must be scheduled with the Karuk Tribe with a minimum of forty-eight (48) hours' notice, and will be the responsibility of the Contractor.

Task One – Trenching/Concrete

There will be approximately 100 feet of trenching, and a cultural monitor on site at all times of soil disturbance. Must install a 15'X25'X4" concrete slab, with #5 rebar at 18" on center. Concrete must meet 3500 PSI compression strength, and must take three cylinders for testing.

Task Two – Installation

All wiring, conduits, automatic switch gear, and other electrical equipment will be properly sized and installed in accordance with **Federal, State, and Local** codes. All wiring, conduits, and other electrical equipment will be installed in a neat and organized fashion. Unsatisfactory work will not be accepted by the owner until rectified by the Contractor at their sole expense. All wiring and equipment will be clearly and properly marked to know their purpose. Contractor must supply and install appropriately sized propane fuel tank/tanks and all necessary plumbing.

Task Three – Clean up

All manuals and information on the unit will be submitted to the owner at the completion of the project. A general walk-through of the operation will be done with Tribal employees. All equipment will be inspected by an Owner representative throughout the project, and testing will be completed before the project is considered satisfactory. The contractor will be responsible for the initial start-up of the generator. Any damage to the facility and/or equipment as a direct result of the project will be repaired by the Contractor. All remaining project debris and materials will be properly disposed of by the Contractor at this time, and the area will be left in a condition equal to or better than found.

Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with an attached schedule of values page.
- 4) Construction Schedule and lead times are required.

5) Names and telephone numbers of three client references.
