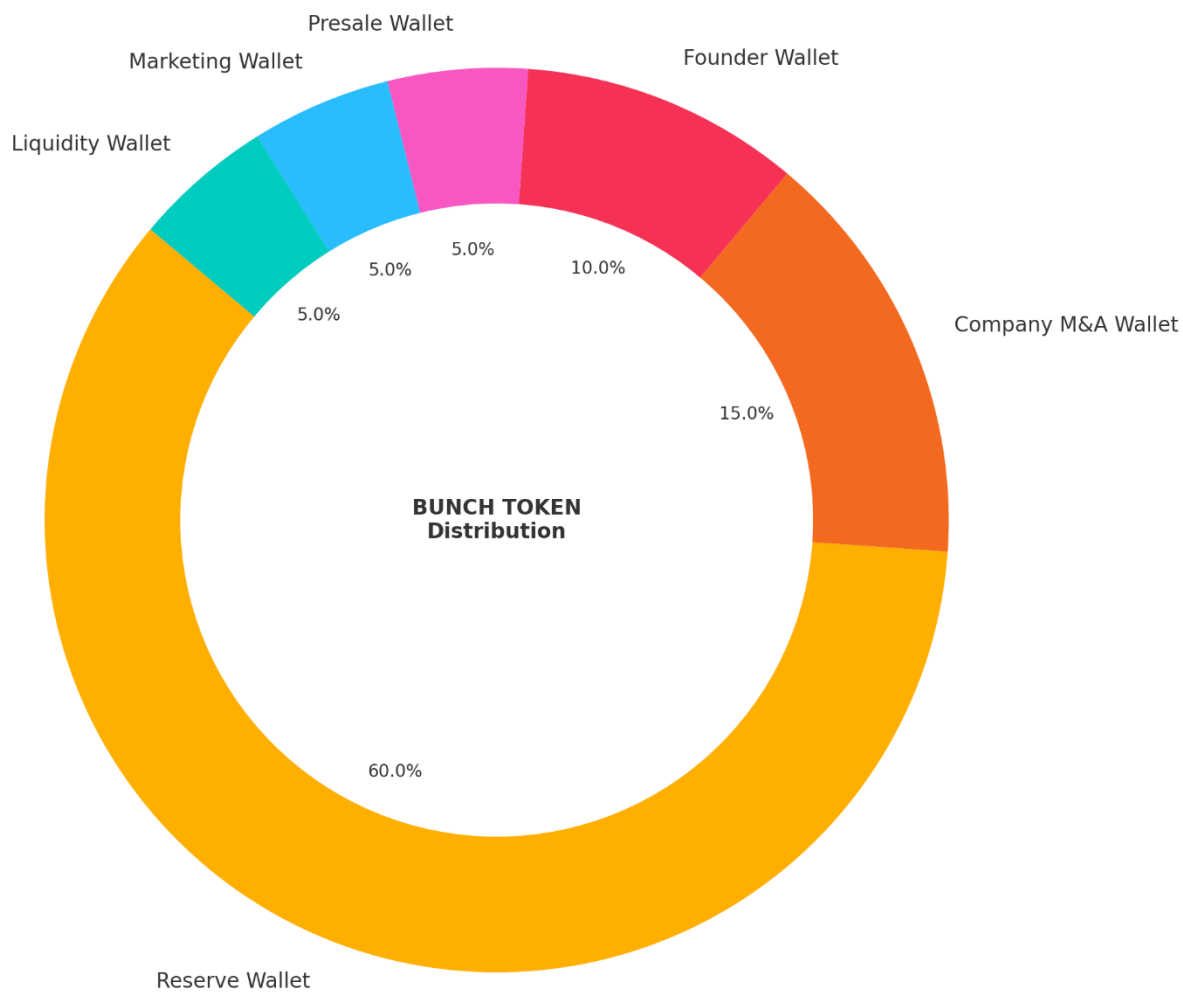

BUNCH TOKEN – TOKENOMICS**1.Total Supply**

Total BUNCH token supply: 1,000,000,000 (1 billion)

(This is a fixed supply. The Support Wallet is not included in this fixed supply.)

2.Token Distribution



Wallet Name	Ratio	Amount (out of 1 billion)	Description
Reserve Wallet	60%	600,000,000	Locked for 3 months. Then, 5% is unlocked every 30 days. All tokens are fully unlocked in 20 months.
Company M&A Wallet	15%	150,000,000	Locked for 3 months. 50% unlocked at 3rd month, remaining 50% at 6th month.
Founder Wallet	10%	100,000,000	Locked for 12 months. Afterward, 5% is released each month.
Presale Wallet	5%	50,000,000	Immediately unlocked. Unsold tokens are transferred to Reserve Wallet.

Wallet Name	Ratio	Amount (out of 1 billion)	Description
Marketing Wallet	5%	50,000,000	Used for collaborations and promotions.
Liquidity Wallet	5%	50,000,000	Used for swap operations. If presale fails, tokens taken from here are transferred to Reserve Wallet.

Support Wallet: This wallet is not included in the fixed supply. It is funded by the 2% contribution fee from buy/sell transactions. Purpose of use:

- Capital for company setup and vineyard acquisition
- Investor rewards until company revenue is generated
- Liquidity support mechanism
BUNCH tokens in the Support Wallet are sold daily through a bot to generate USDT revenue. The reason for daily sales is to reduce price fluctuations.

3.Vesting Schedule

3.1.Reserve Wallet

- Locked for 90 days
- Then: 5% released every 30 days
- Unlock duration: Total 20 months

3.2.Company M&A Wallet

- Locked for 3 months
- 50% released in 3rd month, remaining 50% in 6th month

3.3.Founder Wallet

- Locked for 1 year
- Then 5% released monthly

3.4.Presale Wallet

- Immediately unlocked
- Unsold tokens → transferred to Reserve Wallet

4. Membership and Reward System (Staking-like structure)

Membership Level	Token Amount	Reward Rights
Platinum	50,000+	Share of company profit + voting + participation in branding process
Gold	15,000–49,999	Token reward from Marketing Wallet
Silver	5,000–14,999	Special rewards through contribution points, early access
Bronze	1–4,999	Right to participate in contests

Special Rewards:

Silver and above members earn points for their contributions (getting others to buy BUNCH, tweeting, etc.) and receive the following privileges:

- Special invitations to advertising/promotional events
- Participation in early wine tasting events
- Golden Vanguard badge (with participation condition)
- Right to participate in general voting

5. Four Features That Distinguish the Tokenomics Structure

1. Real asset backing:

The token is backed by physical vineyard acquisition and wine production. In other words, it has a tangible economic value.

2. Mutual growth of value and company:

As the token's value increases, vineyards are acquired, and the company grows. As the company grows, more profit is distributed, which further increases token value.

3. Community participation, Platinum members lead:

Everyone is part of the community, but Platinum members not only receive profit shares; they also have a say in strategic decisions and shape the process like company partners.

4. **Reward for contributing investors:**

Not only token holders, but also those who contribute receive rewards such as special invitations and golden badges.
