The Challenge: 1st University CU set out to become a CDFI and knew financial wellness had to be more than a buzzword.

\$500K+ in relief

With the support of **Starlight**, 1st University Credit Union empowered its members to uncover over \$500,000 in government assistance eligibility and receiving personalized guidance, recognized with a 2025 Tekkie Award for People Helping People.



In under a year, Starlight helped members discover benefits they never knew they qualified for, unlocking over \$500K in tangible financial support.

1st University was able to go live with the solution in just two weeks, delivering immediate value to members without disrupting day-to-day operations.
