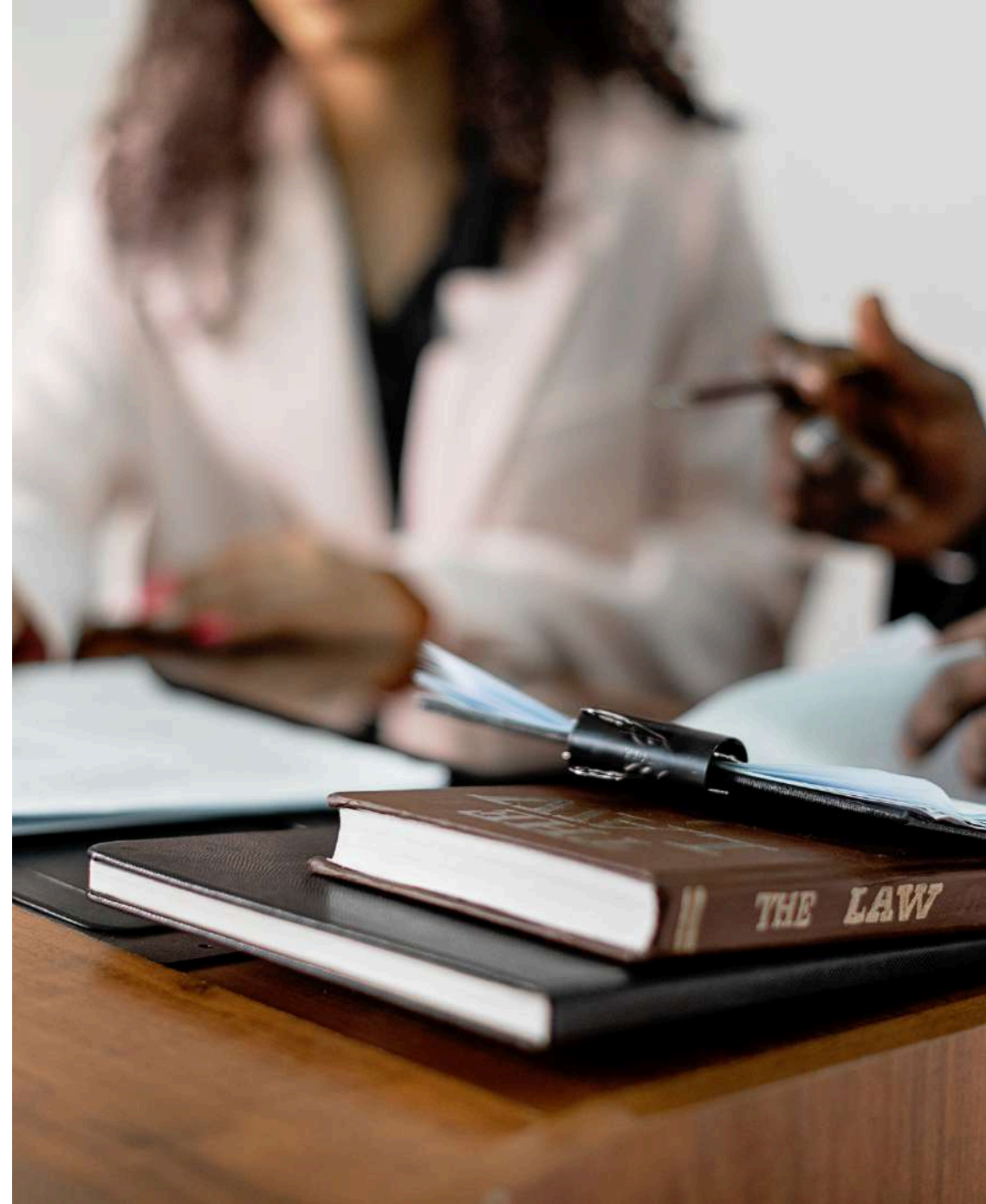
Legal Communication and Advocacy
