



MEMBERSHIP AGREEMENT

The **Global Network of Evangelists** exists to identify, affirm, equip, and mobilize you with the resources and relationships you need to fulfill God's call on your life as a worker in evangelism. Your faithfulness to the following commitments will better enable us to have a fruitful long-term partnership for the purpose of spreading the Good News. In becoming a member of GNE, you agree to the following:

PARTICIPATE in at least one GNE sponsored event per calendar year.

Two main components of our mission are 1) to provide opportunities for our members to evangelize and 2) to provide opportunities for them to get further training to grow their ministry. In order for us to fulfill this mission, we ask you to attend one of the following per calendar year: An GNE sponsored evangelistic event, an GNE Connect Conference, or a Palau Festival. You can also serve with a GNE Partner Evangelist's event, join an Advance Group, request coaching, attend a GNE-hosted webinar or prayer call, or make a visit to the GNE Headquarters.

PARTICIPATE regularly in the life of GNE.

Make the best use of GNE prayer calls, coaching, resources, Advance Groups, and other available opportunities.

PROVIDE regularly updated information about your ministry events and report results to our office upon request (i.e. for the GNE Year-End Report).

We want to promote your ministry on our website, through social media, in our newsletters and with Palau! GNE also wants to encourage you, pray for you, and lend assistance if we have the capability. Your regular communication with us will help to achieve this.

Members are expected to honor and fulfill agreed upon financial obligations. We recommend all parties sign an agreed upon Memo of Understanding (MOU) before entering into collaborative missions and any joint venture. The MOU should define what is expected of all parties involved in the joint venture including any financial obligations.

Be committed to the Biblical mandate to both learn and teach others.

...and what you have heard from me in the presence of many witnesses entrust to faithful men, who will be able to teach others also. (2Timothy 2:2)

PLEASE respect confidential information.

As a member of GNE, you may periodically have access to confidential information of another member, or of Palau. Members are expected not to divulge or utilize confidential information without permission.

GNE CODE OF CONDUCT

Global Network of Evangelists (GNE) members are expected to uphold the highest standards of ethical, professional behavior, above reproach in the sight of God and man. To that end, GNE members should dedicate themselves to carrying out their missions with honesty, trustworthiness, fairness, integrity, and respect for others.

GNE members are expected to obey the laws of both the United States and/or the laws of the respective countries in which they serve. Members should act in such a manner as to uphold and enhance personal honor, integrity, and dignity. Members should treat with respect and consideration all persons, regardless of race, religion, gender, maternity, marital or family status, disability, age, or national origin.

Members should recognize that the chief function of their ministry at all times is to serve God and the best interests of its constituencies. Members should recognize they are ambassadors for Jesus Christ.

As GNE members and evangelists, members should accept it as a personal duty to conduct themselves at the highest level of transparency, honesty, integrity, and humility.

GNE reserves the right to terminate a member's GNE membership if it believes these standards are not being followed.

INDEMNIFICATION

Each Global Network of Evangelists (GNE) member agrees to indemnify, and hold harmless GNE and Palau and its officers, directors, employees, and agents (the Indemnified Parties") against any and all liability, loss, damage, or expenses that any Indemnified Party incurs on account of any claim, lawsuit, or other judicial dispute arising on account of any action (or alleged action) by the GNE member or any of its owners, directors, officers, employees, or agents. GNE members using any Palau brand will include an express disclaimer of any warranties with respect to the services or products provided by the GNE member and an express agreement by any user not to sue GNE on account of any alleged breach of contract, tort, or other claim by the user against Palau and GNE.
