

Privacy Policy (U.S.) — Beverage Seal

This Privacy Policy explains how **Beverage Seal LLC** (“Beverage Seal,” “we,” “us”) collects, uses, and shares information when you visit [www.beverageseal.com] or contact us by phone/SMS.

1) Information we collect

Information you provide: name, company, email, phone number, address, and the contents of your messages/inquiries.

Information collected automatically: IP address, device/browser details, and basic website usage data (via cookies or similar tools).

2) How we use information

We use information to:

- respond to inquiries and provide quotes/product information
- communicate with customers/prospects about your request or relationship with us
- process orders, fulfill shipments, and provide customer support
- secure our website, prevent fraud, and comply with legal obligations

3) SMS and phone communications

We may contact you using a U.S.-based business telephone number. If SMS is enabled, texts are intended for **conversational, one-to-one business communications** (not mass marketing).

- **Message frequency:** varies based on your interaction
- **Fees:** message & data rates may apply
- **Opt out:** reply **STOP** to end texts at any time
- **Help:** reply **HELP** or contact [admin@beverageseal.com]

4) How we share information

We will not share your opt-in to an SMS campaign with any third party for purposes unrelated to providing you with the services of that campaign. We may share your Personal Data, including your SMS opt-in or consent status, with third parties that help us provide our messaging services, including but not limited to platform providers, phone companies, and any other vendors who assist us in the delivery of text messages.

All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

We may share information with:

- service providers that help operate our business (e.g., phone/SMS provider such as Zoho Voice, CRM, hosting, analytics, shipping/payment partners)

- authorities or advisors when required to comply with law or protect rights/safety

We do not sell personal information. We also do not share personal information for cross-context behavioral advertising.

5) Cookies

We may use cookies/similar technologies for site functionality and analytics. You can control cookies through your browser settings.

6) Data retention

We keep personal information only as long as reasonably necessary for the purposes above, unless a longer period is required by law.

7) Your privacy rights (including certain state laws)

Depending on where you live and applicable law (e.g., California and other state privacy laws), you may have rights to **access, delete, or correct** certain personal information, and to **opt out** of certain data uses where applicable.
