Coba Referral Program

Invite Your Friends

The Coba Referral Program ("Program") is a promotional referral program for existing Coba Account Holders ("Account Holder(s)"). Coba Account Holders will be compensated for referring potential customers ("Referral(s)") to Coba, subject to the Program Terms stated herein. By choosing to participate in Coba's Referral Program, the Account Holder and Referral agree to all Program Terms and Information.

Eligibility

To be eligible to participate in this Program, you must be an active Account Holder in good standing. Coba has the right to determine if an account is in good standing and is eligible for the referral bonus. Accounts that are suspended or are flagged for insufficient balances or improper use will not be considered eligible to participate in this Program.

Program Terms

Any Account Holder is eligible to receive a \$25 USD referral reward when they refer a new client (the "Referral") to Coba, under the following conditions:

1.1. The Referral must:

- Referral must be a new Coba Account Holder with no current or prior Coba US Deposit accounts.
- Referral opens a Coba US Deposit account, defined as a US Deposit Account with Bangor Savings Bank through Coba, using a unique referral link or code provided by the Account Holder.
- The Referral's newly opened US Deposit account will receive a Qualified Direct Deposit¹ of at least \$500.00.
- The Qualified Direct Deposit must have been posted and settled to the Referral's account within 45 calendar days of the account opening date.²
- The \$500+ USD deposit must remain in the Referral's account for at least 30 consecutive days from the initial deposit date. If the balance falls below \$500 USD within this period, the Account Holder will not be eligible for the reward.

² The date of account opening is the date on which the US Deposit Account is opened with Bangor Savings Bank

1.2. Upon satisfaction of these conditions by the Referral, the Account Holder will receive a one-time \$25 USD reward.

Referral Conditions

The Referral will not receive any monetary or promotional reward for being referred under this program. The program is designed to reward the Account Holder for introducing new Coba Account Holders to Coba.

Additional Program Limitations

- 3.1. **Self-Referrals**: Account Holders may not refer themselves or create duplicate US Deposit accounts in an attempt to earn multiple rewards. All referrals must be to new, legitimate users who have not previously held a US Deposit account with Coba.
- 3.2. **Reward Limitations**: Each Referral can only count toward a single referral reward. The Account Holder is entitled to multiple referral rewards, as long as each Referral meets the program's eligibility criteria. However, only one Account Holder can be rewarded per Referral.
- 3.3. **Referral Tracking**: To ensure proper tracking of referral activity, Referrals must use the unique referral link or code provided by the Account Holder during account registration. Failure to use the appropriate referral method will result in no reward being issued.
- 3.4 Each Account Holder may earn no more than \$500.00 in referral rewards.

Reward Payment

- 4.1. The \$25 USD reward will be credited directly to the Account Holder's Coba US Deposit Account within five (5) business days following the fulfillment of the Referral's deposit condition.
- 4.2. Coba reserves the right to delay or withhold rewards if fraudulent or suspicious activity is detected.

Referral Invitations

You may send one invite to each friend you invite. You acknowledge that any efforts to bypass, manipulate or otherwise modify the delivery and accurate presentation of the referral link provided will be considered a violation of these Program Terms resulting in ineligibility to participate in the Program.

Other Program Information

Coba is not responsible for incorrect entries or other failures on the part of the Referral to meet the standards to qualify for a Coba US Deposit account.

Coba may, at its sole discretion, offer uncapped or enhanced referral rewards, or other program benefits, to specific Account Holders based on criteria determined by the company. These adjustments may include, but are not limited to, increasing the reward amount, waiving certain eligibility conditions, or expanding the program's scope. Such adjustments will be communicated directly to the selected Account Holders and will not alter the general terms of the Referral Program for other users unless otherwise specified.

Referral bonuses will not be given for Referrals who already have opened, or have attempted to open, a Coba US Deposit account. If two or more individuals invite the same individual to open a Coba US Deposit account, Coba will credit the bonus to the account holder whose referral link was received first. This Program is not valid with any other offers and is non-transferrable. The Program is available to U.S. and Mexico residents only and is void where prohibited. Coba reserves the right to terminate or modify this program and/or these Program Terms at any time at its sole discretion.
