WHAT DOES BEAUMONT FINANCIAL ADVISORS, LLC, d.b.a. BEAUMONT FINANCIAL PARTNERS, (“Beaumont”) DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect, and share, depend on the product or service you have with us. This information can include:

- Social Security number and income
- Tax and asset information
- Account balances and account numbers
- Investment experience and account transactions

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information, the reasons Beaumont chooses to share, and whether you can limit this sharing.

Reasons we can share your personal information	Does Beaumont share?	Can you limit this sharing?
For our everyday business purposes — such as processing your transactions, maintaining your account(s), responding to court orders and legal investigations, or reporting to credit bureaus	Yes	No
For our marketing purposes — to offer our products and services to you	Yes	No

For our affiliates’ everyday business purposes— information about your transactions and experiences	Yes	No

For nonaffiliates to market to you	No	We don’t share

What we do

How does Beaumont protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secure files and buildings.

How does Beaumont collect my personal information?

We collect your personal information, for example, when you

- open an account or give us your income information
- tell us about your portfolio or seek advice about your investments
- enter an investment advisory contract with us

We also collect your personal information from other companies, such as the custodians who hold your account assets.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies.

- *Our affiliates include Focus Operating, LLC. and Focus Risk Solutions, LLC.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- *Beaumont does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Beaumont does not jointly market.*
