We conduct comprehensive risk assessments for each project, ensuring that safe work procedures are established and strictly followed.

## 4. Training and Competency

Our team is highly trained and competent in all aspects of workplace safety, with a particular focus on the unique hazards associated with marine electrical work. Our training programs ensure that all personnel:

- Understand their WHS responsibilities.
- Are competent to perform their assigned tasks safely.
- Are aware of emergency procedures.
- Receive regular refresher training to stay updated with the latest WHS regulations, industry best practices, and technological advancements.
