Contestants on "American Idol" Season 23 are rapidly dwindling down to the best of the best, and Meridian native Jamal Roberts is holding steady in

Monday night, April 21, six of the Top 20 contestants were sent home. Rob-erts earned his Top 14 spot with a smooth rendition of "Try a Little Ten-

derness."
Roberts, a 27-year-old P.E. teacher at
Crestwood Elementary, started his
"American Idol" journey when he won a
golden ticket singing "Mary Jane" by
Rick James in audition rounds. In the weeks since his audition round aired, Roberts has traveled throughout the Roberts has traveled throughout the U.S. with his fellow contestants, elud-ing elimination rounds with his raw, soulful performances. During his audition, judges Luke Bryan, Lionel Richie and Carrie Under-

bryan, Loner Retne and Carrie Onder-wood were blown away by Roberts' vo-cals, but told the singer he could use some more confidence to match his powerful voice.

Roberts has since grown his stage presence, and even performed Jelly Roll's "Liar," in front of the artist him-

presence, and even performed Jeny Roll's 'Liar,' in front of the artist himself, prompting Jelly Roll, this season's artist in residence, to declare the song "Jamas" song."

Monday night, fresh from moving the audience to tears with his Sunday night performance of Jason Nelson's "Forever," Roberts owned the stage once again with his animated performance of "Try a Little Tenderness," casually giving Bryan a first bump as he circled the judging station.

## **Hegseth warns 'leakers'** could be prosecuted

WASHINGTON - Defense Secretary Pete Hegseth lashed out at "leakers" within the Pentagon, warning they could face criminal prosecution as he

could race criminal prosecution as ne tried to fend off mounting criticism about his job performance.

A defiant Hegseth addressed his latest controversies in an interview April 22 on Fox News' "Fox and Friends," where he previously worked as a co-host. He said three recently termined. But the property of the propert

as a co-host. He said three recently terminated Pentagon employees — Dan Caldwell, Darin Selnick and Colin Carroll — were put on leave because an internal investigation found they'd fed information to the media.

"If we think you are leaking to the press, that's a very real problem. We take that very seriously at the Pentagon," Hegseth said. "Disgruntled former employees are peddling things to try to save their (expletive), and ultimately, that's not going to work."

Hegseth said the Pentagon launched Hegseth said the Pentagon launched an investigation with the Defense Department's Office of Special Investigations following a series of stories that relied on nonpublic information. He said the investigation 'led to some unfortunate places, people I have known for quite some time, but it's not my job to protect them."

The said the Pentagon plans to turn over information about leakers to the Department of Justice.

"When that evidence is gathered sufficiently – and this has all happened, very quickly – it will be handed over to DOJ, and those people will be prosecuted, if necessary," he said.

Hegseth's appearance came after the New York Times, citing four anonythe New York Times, citing four anonymous sources, reported April 20 that Hegseth shared sensitive military information in a Signal chat with a group that included his wife, brother and personal attorney. The communication mirrored the attack plans on Houthi militants in Yonney they Hogseth militants in Yemen that Hegseth shared in a separate Signal chat of Trump officials the same day that inad-vertently included the editor of The At-

Hegseth did not deny sending the information to his wife, Jennifer Hegseth, a former Fox News producer, or his brother and personal attorney, both of whom have jobs in the Pentagon. But he said the information wasn't war

"I look at war plans every single day. What was shared over Signal then and What was shared over signal then and now, however you characterize it, was informal, unclassified coordinations for media coordination and other things, 'Hegseth said.

Hegseth told 'Fox and Friends' cohost Brian Kilmeade he believes the

story came from information leaked by a terminated former Pentagon employ

"Why would it surprise anybody, Brian, if those very same people keep leaking to the very same reporters, whatever information they think they whatever information they think they can have to try to sabotage the agenda of the president or the secretary?" Heg-seth said. "Once a leaker, always a leak-er, often a leaker." President Donald Trump has stood

behind Hegseth amid the controver-sies, and the White House denied a report by NPR that Trump is looking at potential replacements to lead the Pentagon.

On April 16th, 2025, Gulf South Pipeline Company, LLC (Gulf South), filed an application for its Southeast Compression Utility and Reliability Expansion Project ("SECURE Project" or "Project") with the Federal Energy Regulatory Commission (FERC) under Section 7(c) of the Natural Gas Act in Docket No. CP25-219.

As part of the SECURE Project, Gulf South is requesting approval to make improvements at four locations to help maintain reliable natural gas service in the Southeastern United States. The proposed work includes adding new compressor units and equipment at Gulf South's existing Tallulah Compressor Station in Madison Parish, LA, and Jasper Compressor Station in Jasper County, MS; upgrading Gulf South's Forrest Compressor Station in Forrest County, MS by adding a new compressor unit, modifying an existing unit, and installing ancillary equipment; and building a new compressor station in Hinds County, MS, which will include one compressor unit and ancillary equipment
