3. AGREEMENT ON A FUTURE PURCHASE AGREEMENT (AFPA)

Part I:

Within 10 calendar days from the closing of the SOSBK.



Part II:

PAYMENT OF 80% OF THE FUTURE PURCHASE PRICE

Within 10 calendar days from the delivery of the final approval or final approval decision.



4. PURCHASE AGREEMENT AND TAKEOVER OF THE UNIT

After payment of the full purchase price, the purchase contract is signed, the unit is taken over and entered into the real estate register.
