

WAIVER OF LIABILITY

Effective Date: October 1, 2025

1. Acknowledgment and Assumption of Risk

By clicking creating a booking at Doglegg Golf, below, you acknowledge and agree that your use of the facilities, equipment, and services provided by **Doglegg Golf** involves inherent risks, including, but not limited to, injury, property damage, or loss. You voluntarily assume all risks, whether foreseeable or not, associated with your use of the golf simulator, equipment, and any related activities conducted on the premises.

2. Waiver and Release of Liability

In consideration of being granted access to the facility, you hereby release, waive, and discharge **Doglegg Golf**, its owners, employees, agents, contractors, and representatives from any and all liability, claims, demands, actions, or causes of action arising from or related to your use of the golf simulator facility and equipment, including but not limited to any injury, loss, or damage incurred by you.

This release applies to liability caused by the negligence of **Doglegg Golf** or its representatives to the fullest extent allowed by law.

3. Use of Facility and Equipment

You agree to use the golf simulator equipment in accordance with all posted guidelines, rules, and instructions provided by **Doglegg Golf** staff. You accept full responsibility for any damage to the facility or equipment caused by your misuse, negligence, or failure to follow instructions.

4. Medical Conditions and Emergency Care

You confirm that you are in good health and physically capable of participating in golf simulator activities. You acknowledge that **Doglegg Golf** does not provide medical personnel or treatment onsite. In the event of a medical emergency, you authorize **Doglegg Golf** to seek medical attention on your behalf, and you assume all costs associated with such care.

5. Minors

If agreeing on behalf of a minor, you affirm that you are the minor's parent or legal guardian and accept full responsibility for the minor's participation, including the risks and liabilities outlined in this agreement.

6. Indemnification

You agree to indemnify and hold harmless **Doglegg Golf**, its owners, employees, agents, contractors, and representatives from any claims, damages, or costs arising from your actions, conduct, or negligence during your use of the facility and equipment.
